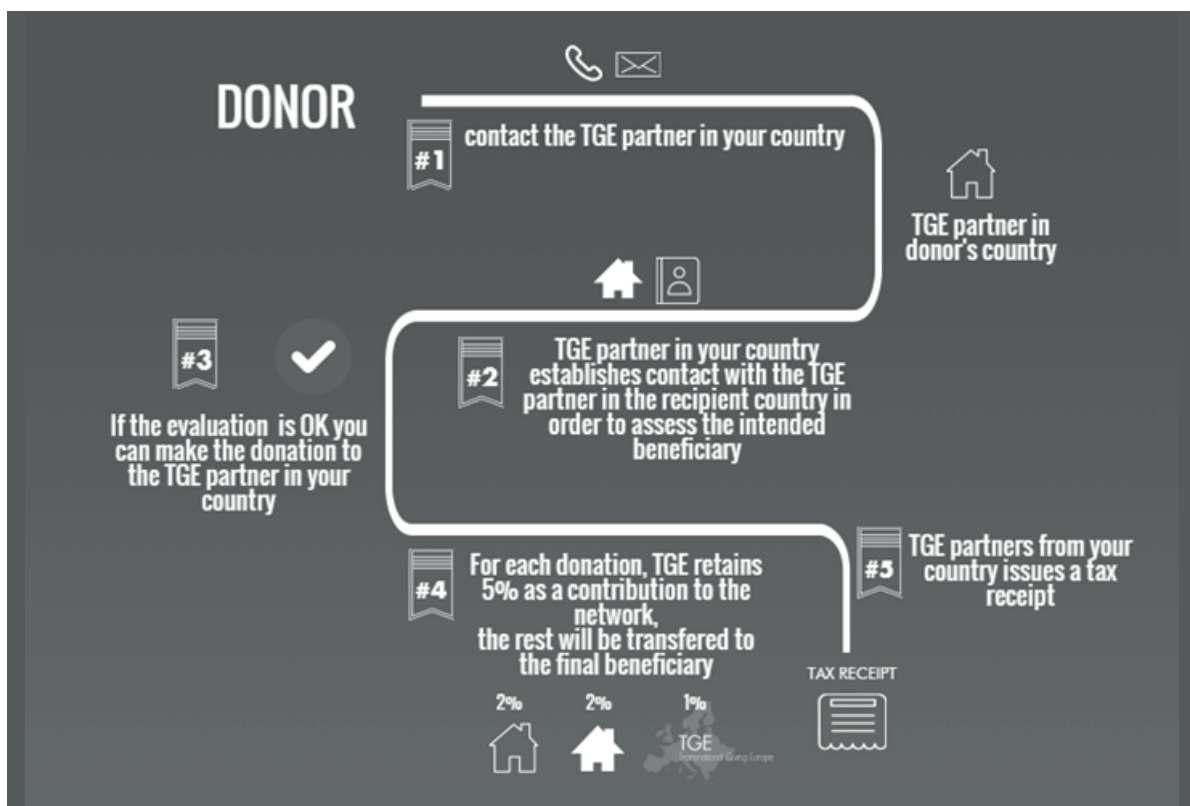

If the evaluation is positive, you can make the gift to your home-country foundation, which then provides you with a tax receipt and transfers the gift to FEDORA.
