Entries must have been completed within the <u>last 3 years</u> and never have won a top award in an EPAA exhibit. Any entry deemed obscene or pornographic or not meeting exhibition criteria may be rejected by the Exhibition Committee at their discretion. This exhibit will be open to EPAA members & non-members. All artwork must be for sale. The Crossland Gallery will collect and pay state sales tax and retain its regular 30% commission on any artwork that sells.

Due to limited space, not all entries *may* be accepted. Entries will be accepted in the order received. ONLY if your entry exceeds the maximum for the show, you will be notified by and your entry fee will be returned. Entry fees for accepted work are non-refundable.

#### MEDIA AND EXECUTION

Entry Size Requirements <u>INCLUDING</u> frame or gallery wrap: <u>Minimum</u> 12" by 16" or 192 sq in, <u>Maximum</u> 48" by 48". Art that comes in larger or smaller than required, may at the EPAA discretion be accepted but will <u>NOT</u> be judged. Entries will be accepted in the following media categories:

- Oil, alkyd, encaustic; Aqua media-watercolor, gouache, or acrylic
- Sculpture Bases of sculptures on pedestals may not exceed 24" at base and 30" in height. Sculpture base and handling of sculpture will be the responsibility of the artist.
- Mixed Media-includes pastel, egg tempera, scratchboard, charcoal, pen & ink, vinyl, epoxy paint, pencil and any mixed media combination (Collage is acceptable if it is composed by assembling, pasting, or gluing materials onto a flat surface
- Photography, painted photography, digital photography is accepted.
- Prints must be hand pulled by the artist.
- No photographic reproductions of original work.
   Giclées will not be accepted.
- Fiber art 2D or 3D, artwork but be stable and ready to hang on wall or placed on pedestal supplied by artist.
- Frames must be substantial and include mechanics for hanging. Gallery Wrapped canvas are accepted.
- No saw tooth hangers or wet paintings.
- Labels must be placed in the lower left hand corner on the back of all artwork and must include:
   Exhibitor's name, phone, title, medium, and price.
   All entries may include an artist's Bio or information sheet.

#### **PUBLICITY:**

To be eligible for publicity, please submit online entry form, payment & images NO LATER THAN May 15, 2017. Submitting images with your entry form is always encouraged for all submissions by not required for this show.
