- **February 28, Friday 11am-4pm** - Close of Show

- **March 3, Tuesday 11- 4pm** - Pick-up artwork

Failure to pick up artwork by March 3 will result in a \$5per day, per piece fee. No exceptions.

GUIDELINES

Artists are invited to create artwork based on the human form or portrait. Artwork will emphasize the figure or portrait and be the main subject of the finished piece. Entries must have been completed within the last three years and never have won a top award in an EPAA exhibit. Push Pin Award: artwork should have been done within the last year. Abstract to realistic styles and all mediums accepted in 2D and 3D. Nudes will be accepted, however, art deemed vulgar or not meeting exhibition criteria will be rejected by the EPAA.

***Push Pin Award** – Figurative work from “life drawing” done within the last year.

All mediums. Max 18”X24”. No Minimum size.

NO FRAMES for Push Pin Award entries. Artwork will be *push pinned* to wall.

MEDIA AND EXECUTION

Entry size requirements **INCLUDING** frame or gallery wrap:

Minimum 11” by 14”, **Maximum** 48 width” by 60 height”.

DO NOT BRING IN ARTWORK THAT DOES NOT MEET THESE REQUIRED SIZES!!!

Above sizes are not for Push Pin Award, see guidelines.

Entries will be accepted in the following media categories:

- Oil, alkyd, enamel, encaustic, water media including: watercolor, gouache or acrylic.
- All mediums including: pastel, egg tempera, scratch-board, charcoal, pen & ink, vinyl, epoxy paint, pencil and any mixed media combination & collage.
- All photography.
- Printmaking/prints must be hand pulled by the artist.
- No photographic reproductions of original work.
- Sculpture – most sizes accepted call for details.
- Fiber art 2D or 3D, artwork must be stable and ready to hang on wall or placed on pedestal.
- No saw tooth hangers or wet paintings.
- **FRAMES** must be substantial and include mechanics for hanging, dust and finger print free. Gallery wrapped canvas are accepted. **DO NOT BRING IN ART THAT DOES NOT HAVE A WIRE HANGER ON THE BACK! D-RINGS ARE PREFERRED!! NOTE: If you do not know how to properly wire your artwork, please google and watch various Youtube videos to learn how to properly wire your artwork!! THIS IS VERY IMPORTANT! YOUR ARTWORK DESERVES IT!!**

LABELS

Labels must be placed in the lower left hand corner on the back of all artwork and must include:

Exhibitor’s name, phone, title, medium, and price.

All entries may include an artist’s Bio or information sheet.

PUBLICITY

Artwork images submitted on-line can be used whole or in part for publicity purposes.

ART SALES

All artwork must be for sale! The Crossland Gallery will collect and pay state sales tax and retain 30% commission on sold artwork. Due to limited space, not all entries MAY be accepted. Entry fees for accepted work are non-refundable.
