THE BEGINNING OF A NEVER ENDING (?) WAR

Found hidden away in a drawer in an old North Dakota farm home, was a newsprint magazine very similar in appearance to the Parade magazine insert in present day Sunday newspapers. This one had a most intriguing title: “1942 WAR ATLAS edited by H. V. Kaltenborn, Published by Pure Oil Company.” Behind the cover, page one, was Kaltenborns “*Chronology of World War II*”*. The final entry about WWII’s beginning: Jan. 15, 1942.

Most of today’s Americans likely are only dimly aware that World War II began almost three years before Pearl Harbor December 7, 1941. In the Chronology, listed are 142 events, the first being Jan 14, 1939: “**Britain protests to Japan against violations of NINE POWER TREATY.**” December 7, 1941 is entry 125. The United States was officially at War after 23 years of relative peace.

The “Old War”, as Grandma called WWII, began to end this time of year in 1945, with Germany surrendering in May, Japan holding out till September. August 6&9 came the A-bombs (which Grandma applauded – she saw it saving her son, for three long years a Naval Officer on a Destroyer in the Pacific.) “Hurrah, the old war is over”, Grandma said in a letter after the bomb. War is like that: individual and tribal survival. It is deadly short-term thinking.

Then came Peace...for not much more than a year. People were sick and tired of war and ready for peace; as they had been after the deadly “War to end all Wars” ended in 1918. The United Nations was founded 70 years ago in October.

But war drums are hard to silence. There seems, always, the next, essential, certain-to-be successful war.

The May 2015 American Legion Magazine (pp 30-38)* briefly catalogues U.S. wars over its history. Post 1941, the author concedes about a year or two of peace – between WWII and Korea.

Then are listed, the “Cold War”, (1947-91); assorted Middle East conflicts, like Iraq; the presumptive never-to-end (till we obliterate ourselves) Global War of Terrorism, (2001 to the present).

It seems that a perpetual war has been declared on our watch.

Yes, The conversation can change. But we as individuals are the only ones who can change that conversation.

NEWS FROM THE WORKABLE WORLD TRUST (WWT)

Joe Schwartzberg, Director, WWT

Planning for the conference on “**CREATING A WORKABLE WORLD**” is proceeding nicely. The program is now almost completely set and is laid out in the flier inserted in this newsletter. It’s going to be a rich and unforgettable experience. We hope to fill all 250 seats in the conference venue, the Cowles auditorium at the Humphrey School of Public Affairs at the University of Minnesota and expect substantial registration from out-state activists and students from the US and Canada So mark your calendars now, spread the word, and register early. (Thanks to Nancy Dunlavy for her amazingly efficient coordination of the planning process.)

Our March newsletter reported plans for translating Joe’s book, *Transforming the United Nations System: Designs for a Workable World*, into seven major languages. We noted that contracts had already been signed for translations into Chinese, Japanese, Russian and Spanish. We have since added Arabic and French to that list and expect soon to add German as well.

One of several other Trust initiatives was to underwrite most of the cost of sending Shimri Zameret, an Arabic-speaking Israeli to represent the World Federalist Movement (WFM) at the periodic World Social Forum, which was held in March, 2015 in Tunis, with an attendance of 70,000 persons from some 5,000 civil society organizations. There he spread news of the WFM, the WWT and the concept of world citizenship. He had a remarkable set of contacts and delivered a report on his own and other activities that was truly remarkable.

In respect to UN reform, Joe has focused in recent months primarily on the Security Council. He has visited and corresponded with staff of the UN missions of India, Brazil and Germany working on that issue and corresponded also with staff from Japan. The following letter from the German mission is worth quoting:

Dear Prof. Schwartzberg,

On behalf of Amb. Braun, I wish to thank you for your letter of 6 April, including your thoughtful proposal for a Security Council based on a regional system with weighted voting. I read your proposal attentively, as I have done with your 2013 book “Transforming the UN System”.

As you know, Germany, along with the G4 countries Brazil, India and Japan, is actively advocating for a more effective and representative UN system, especially the UN Security Council. In our view, the 70th anniversary of the United Nations presents an important opportunity for member states and the international civil society to refocus attention on this long overdue aspect. Your contribution to this debate is most welcome.
