LSU Athletics Department policy requires that student-athlete employment be monitored in order to ensure compliance with National Collegiate Athletic Association (NCAA) and Southeastern Conference (SEC) rules and regulations. After completing the form(s), please return it to us by saving the PDF file and sending it as an attachment in an e-mail to mjakoubek@lsu.edu. If you prefer, you may fax the form to the attention of the Compliance Office at 225-578-2430. The information collected will be used to verify employment details.


In addition, please note that you may be contacted by telephone, or a member of the LSU Compliance staff may perform a site visit at your place of business to ensure that our student-athletes are working at the times indicated on the form.

As a reminder, NCAA rules governing employment of student-athletes are as follows:

- (a) The student-athlete is compensated only for work actually performed;*
- (b) The student-athlete is compensated at a rate commensurate with the going rate in that locality for similar services; and*
- (c) The student-athlete's compensation may not include any remuneration for value or utility that the student-athlete may have for the employer because of the publicity, reputation, fame or personal following that he or she has obtained because of athletics ability.*

We appreciate your cooperation in ensuring that the employment of LSU student-athletes is in accordance with NCAA and SEC rules and regulations. FORM B: EMPLOYER AGREEMENT

As the employer of a Louisiana State University student-athlete, I agree to abide by the rules and regulations as set forth by the *NCAA Division I Manual*, Section 12.4.1:

12.4.1 Criteria Governing Compensation to Student-Athletes.

Compensation may be paid to a student athlete:

- (a) Only for work actually performed; and
- (b) At a rate commensurate with the going rate in that locality for similar services.

12.4.1.1 Athletics Reputation.

Such compensation may not include any remuneration for value or utility that the student-athlete may have for the employer because of the publicity, reputation, fame or personal following that he or she has obtained because of athletics ability.
