TUITION POLICY

THERE IS A ONETIME, YEARLY REGISTRATION FEE OF \$25 FOR ALL NEW DANCE STUDENTS AT THE TIME OF ENROLLMENT. THIS FEE IS DUE AT THE START OF EACH NEW SEASON (AUGUST).

ALL TO THE POINTE FAMILIES ARE REQUIRED TO PROVIDE A CREDIT CARD ON FILE AND GO THROUGH OUR AUTOMATIC PAYMENT PLAN. TUITION AND ANY OUTSTANDING BALANCE WILL BE WITHDRAWN FROM YOUR CARD ON FILE ON THE LAST DAY OF EACH MONTH FOR THE PROCEEDING MONTH. (FOR EXAMPLE: TUITION FOR AUGUST WILL BE DUE ON JULY 31ST). WE ACCEPT CASH OR CHECK PRIOR TO THE LAST DAY OF THE MONTH. IF WE DO NOT RECEIVE A PAYMENT BEFORE TUITION IS DUE, YOUR CARD ON FILE WILL BE CHARGED THROUGH OUR AUTOMATIC SYSTEM. ANY DECLINED CARDS WILL HAVE A \$5.00 ADMINISTRATIVE FEE.

IF YOU JOIN OUR STUDIO IN THE MIDDLE OF THE MONTH, WE WILL PRORATE YOU FOR THAT MONTH. THERE WILL BE A \$25 FEE CHARGED FOR ANY RETURNED CHECKS. ALL CREDIT CARDS ARE WELCOME: VISA, MASTERCARD, DISCOVER AND AMERICAN EXPRESS.

AUTHORIZATION FOR DIRECT PAYMENT

IN ORDER TO AUTHORIZE THIS POLICY YOU MUST COMPLETE THIS FORM. TTP STUDIO & COMPETITION POLICY CONTRACT

PER TO THE POINTE'S STUDIO POLICIES, I UNDERSTAND AND AGREE TO HAVING A CREDIT CARD ON FILE FOR AUTO TUITION WHICH WILL BE DRAWN ON THE LAST DAY OF THE MONTH FOR THE PRECEDING MONTH. IF I WISH TO PAY WITH ANOTHER METHOD THAN THE CARD ON FILE I MUST DO SO BEFORE THE LAST DAY OF THE MONTH. PER TO THE POINTE'S COMPETITION POLICIES, I UNDERSTAND AND AGREE THAT MY CHILD WILL FULFILL ALL CLASS REQUIREMENTS IN ORDER TO BE ON TEAM. I UNDERSTAND AND AGREE THAT MY CHILD WILL ATTEND ALL REQUIRED REHEARSALS AND CHOREOGRAPHY CLASSES FOR THEIR TEAM UNLESS EXCUSED (*SEE POLICIES). I UNDERSTAND AND AGREE THAT IN ORDER TO BE REGISTERED FOR A SOLO/DUET/SPECIALTY DANCE FOR COMPETITION I MUST NOTIFY TAYLOR BY THE DEADLINES GIVEN.
