Refunds. All registrations are non-refundable and only valid for original Dance Experience Live, Inc. (“DEL”) event (“Event”), date and location of purchase. No exceptions.

Credits. On a case-by-case basis, registered participants who wish to withdraw prior to the Event’s start date due to illness or injury may do so if authenticated with an official doctor’s note. Participant will be credited the cost of the Event to be used towards a future Event produced by DEL, minus a \$25 administrative fee. Credits are valid for one calendar year and will not be issued for any other reason.

Wristband Policy. Registrants receive only one band for the workshop. Wristbands may not be removed for the duration of the convention. Lost or removed bands require full repayment of registration fee. Pre-registration is strongly suggested as some bands may sell out. Wristbands may not be transferred from one person to another. DEL is not responsible for lost or stolen bands

Waitlist Policy. If you are completing a waitlist registration, an amended confirmation will be sent to the email address you provided. Please note that in the event that space becomes available, your credit card will automatically be charged and you will be registered for the Event.

Disclaimer. DEL staff reserves the right to remove any person (or persons) who presents potential harm, danger or disruption to themselves or anyone else while attending the Event. Due to contractual obligations, DEL guarantees minimum faculty as noted on Event website; faculty is subject to change.

Liability Release. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I agree to release and hold harmless DEL, the Event, the facility on whose premises the Event I am attending will occur (the “Location”), and the respective directors, officers, representatives, members, agents, affiliates and employees of DEL and the Location and their respective affiliates (hereinafter collectively “Releasees”) from any and all liability, whether based on negligence, contract, tort, statute or otherwise, for any claim, judgment, loss, liability, cost and expenses (including, without limitations, attorney’s fees and costs) arising out of or connected with the Event I am attending, including but not limited to any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that I may incur or sustain during the Event, all activities associated with the Event and while traveling to and from the site for the Event whether or not the Event actually occurs. I further expressly agree to indemnify and hold harmless Releasees and Releasees’ heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by me or by any other persons on the account of damages of any character resulting to me in any way from the foregoing activities. I further agree to reimburse and to make good to Releasees any loss, damages, or costs Releasees may have to pay as a result of any such action, claim, or demand, including but not limited to attorneys’ fees.

Medical Release. I acknowledge and agree that participation in the Event subjects me to the risk of physical illness or injury (minimal, serious, catastrophic and / or death) and that I acknowledge that I am assuming the risk of such illness or injury by participating in the Event. I am aware that this Release Waiver Form releases Releasees from liability and contains an acknowledgement of my voluntary and knowing assumption of the risks of injury or illness.
