This is an agreement between Gary J Inc. O/A The Ranch Kennels (hereinafter called the "Kennel" and the animal owner(s) whose signature(s) appear(s) below (hereinafter called the ("Owner"). The Kennel and the Owner agree as follows:

- 1. If the Owner's animal (hereinafter called the "animal") is staying at the Kennel for a term of more than 30 days we require a deposit equal to one half the anticipated boarding fees.
- 2. In the event that the Owner has not returned to collect the animal on or before 12:00 p.m. of the scheduled pick up date the Owner agrees to pay the full day's boarding fee.
- 3. The Owner represents that he or she is the sole owner of the animal and that the animal is in good health and has received all required vaccinations and has not been exposed to distemper, rabies or any other infectious diseases or parasites within the last 90 days.
- 4. In the event that the Kennel is unable to reach the emergency contact for the Owner or if the Owner does not immediately provide instructions for the care of the animal to the Kennel, and if the state of the animal's health (in the Kennel's judgment) requires immediate medical attention, the Kennel is authorized (but is not obligated) to make all reasonable efforts to ensure that the animal receives the proper medical attention and may engage the services of a veterinarian of the Kennel's choosing.
- 5. The Owner shall ensure that its emergency contact is aware of the Owner's wishes in case of an animal emergency and that arrangements have been made for such emergency contact to authorize any medical assistance in case of such emergency.

- 6. The owner agrees that it will pay for all medical treatment received by the animal and any other related fees or disbursement incurred in respect of the animal on the Owner's behalf
- 7. The Owner understands and agrees that the Kennel staff is not trained to recognize or diagnose animal ailments or diseases and the Owner agrees that the Kennel will not be liable for any sickness or ailment that the animal develops or manifests during its stay at the Kennel.
- 8. In the event that the Owner has not returned to the Kennel to pick up the animal within 14 days after the scheduled pick up date and has made no other arrangements for payment, pick up or continued boarding, the animal will become property of the Kennel and the animal will be dealt with in such manner as the Kennel determines. Notwithstanding the foregoing, the Owner will remain responsible for any outstanding balance of amounts due to the Kennel.
- 9. Owner agrees to pay in full any damages to persons or property caused by the animal.
- 10. Owner understands that the animal will be socialized with other animals unless the Owner instructs otherwise and the Owner is aware that during socializing the unpredictable can occur at any time and accordingly the Owner will not hold the Kennel liable for any unforeseen incidents with the animal.
- 11. The Kennel is not responsible for damage or loss of any items brought into the Kennel by Owner such as, but not limited to, bedding, toys, chews, food, collars, leads and medication. Items given to animals in housing units will be removed at the discretion of the Kennel.
- 12. Our goal at The Ranch Kennel is to provide the best care possible for your animal. Notwithstanding anything elsewhere contained in this agreement, the boarding of the animal is entirely at the risk of the Owner and the Kennel shall not be liable to the Owner or any other party for any direct or indirect liability, loss, claim, expense or damage that are in any way connected with the services provided by the Kennel hereunder including, without limitation, the death of the animal, any disease that afflicts the animal, the running away of the animal or any accident or injury that occurs to the animal.
- 13. The Owner indemnifies the Kennel for all liability, loss, claims, expenses, damages or injury to the Kennel, its property, or its officers, directors and staff, resulting from the Owner's breach of any of its obligations hereunder or resulting from or contributed to by the animal.
- 14. All amounts owing by the Owner to the Kennel shall bear interest from the scheduled animal pick up date at the rate of 18% per annum.
