Terms and Conditions

The terms "CAC" "we" and "our" refer to Cuba Adventure Company. We are a tour operator registered under the Registry of Joint Stock co. in Nova Scotia which offers and operates all the trips listed herein. Please review the terms and conditions set out below to draw your attention to the fact that our obligations to you are limited.

PRICES, RESERVATIONS AND PAYMENT

Our prices are shown in CAD currency, except for one multi-sport program 'Culture meets Nature' which is exclusively for US citizens in USD currency. We charge a single supplement to individual travellers who wish to ensure that they have private rooms throughout a trip. Full payment is due upon booking with a booking deadline of 30 days from the start of the trip. To complete your reservation, you must complete, sign and return our waiver form within 14 days of the receipt of your confirmation, which will include these forms.

CANCELLATION POLICY If you must cancel your reservation, the fees for doing so are as follows: Number of days prior to your trip:

60+	100% Refund
45-59	75% Refund
30-44	50% Refund
0-29	NO REFUND

In the event of flight cancellations due to: catastrophic natural disasters, security conditions, health hazards and any other government restrictions there will be a full refund issued.

CANCELLATION BY CAC

CAC reserves the right to cancel any trip at any time for any reason determined in our sole discretion, including if there are too few participants, or if the quality of the trip or the safety of travellers is judged by CAC to be compromised. In such a case, refund of payments received by CAC shall be fully refunded. In the event of cancellation, CAC is not responsible for any loss incurred on account of non-refundable or non-transferable air tickets or other unrecoverable travel costs.

PREPARING FOR YOUR TRIP

Our trips entail risks—and rewards—beyond those encountered at home. We count on our travellers to ensure they are healthy and fit; and to appreciate that in Cuba living standards, practices, services and accommodations may differ from those in North America or Europe.

HEALTH

This document will be sent to you upon registration. The document must be completed and returned to us with 14 days of the receipt of your confirmation.
