Your access to and use of the Service is conditioned on your acceptance of and compliance with this policy. The terms described herein apply to all visitors, users and others who access or use the Service.

Gather Activism ("us", "we", or "our") maintains, manages, and develops the Gather mobile applications (iOS and Android) and website (the "Service").

This page informs you of our policies and practices regarding the collection, use and disclosure of personal information when you use the Service.

We will not use or share your information with anyone except as described in this Privacy Policy.

We use your personal information solely to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with the terms described within this policy.

### Information Collection And Use

While using our Service, we will ask you to provide certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to, your name, email address, phone number, mailing address, or other information ("Personal Information").

We collect this information for the purpose of providing the Service, identifying and communicating with you, responding to your requests/inquiries, and improving our services.

We will not monetize the collection of personally identifiable information, however we retain the right to sell any and all non-identifying data.

### Log Data

We collect information that your mobile device sends whenever you visit our Service ("Log Data"). This Log Data may include information such as the type of mobile device you use, your mobile device's unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, your location information, the actions that you take within the mobile app, the time and date of your visit, and other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor and analyze this type of information in order to increase our Service's functionality. These third party service providers have their own privacy policies addressing how they use such information.

### Information Sharing

The Personal Information that you submit to Gather Activism may be shared with the third-party political organizations and communities you opt to join through the mobile application. By selecting to join an organization from the Communities tab within the mobile application, you are agreeing to share your personally identifiable information with that organization. Once provided, your Personal Information will be subject to the privacy policy of the organization receiving your Personal Information and Gather is no longer responsible for how that Information is used, shared, or monetized.

### **Service Providers**

We may employ third party companies and individuals to facilitate our Service, to provide the Service on our behalf, to perform Service-related services and/or to assist us in analyzing how our Service is used.

These third parties have access to your Personal Information only to perform specific tasks on our behalf and are obligated not to disclose or use your information for any other purpose.

### **Security**

When you submit Personal Information via the mobile app or website, your information is protected both online and offline.

Wherever we collect sensitive information, that information is encrypted and transmitted to us in a secure way.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job are granted access to personally identifiable information. The cloud servers in which we store personally identifiable information are maintained with full security.

However, please be aware that no method of transmission over the internet, or method of electronic storage is 100% secure and we are unable to guarantee the absolute security of the Personal Information we have collected from you.

Gather Activism has no control over, and assumes no responsibility for, the content, privacy policies, or practices of any third party web sites or services. ### **Children's Privacy**

Only persons age 18 or older have permission to access our Service. Our Service does not address anyone under the age of 13 ("Children").

We do not knowingly collect personally identifiable information from children under 13. If you are a parent or guardian and you learn that your Children have provided us with Personal Information, please contact us. If we become aware that we have collected Personal Information from a children under age 13 without verification of parental consent, we take steps to remove that information from our servers.
