- Being proactive with community efforts to educate the public about Reentry and how they can participate in the Returning Citizen's journey and success

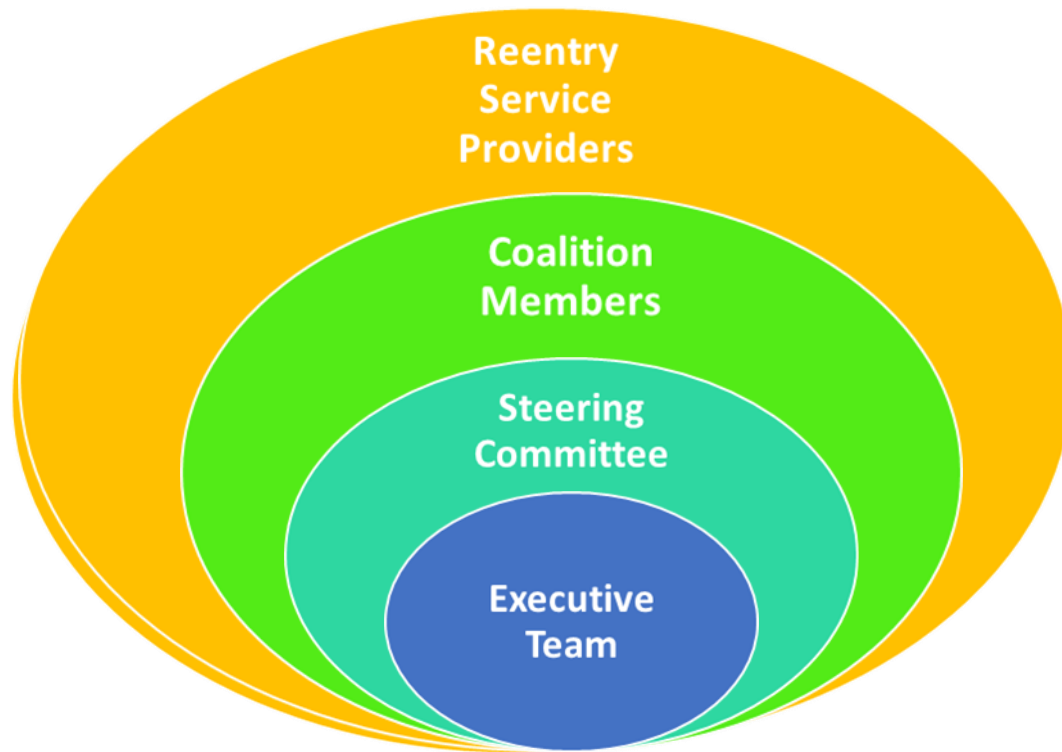
