Mariposa Food Co-op is excited to introduce our Food For All program!

In an effort to make Mariposa Food Co-op more accessible and affordable to low-income communities, qualifying Food For All (FFA) recipients will receive a 10% daily discount. Recipients may also become working owners for an additional 5% discount for a total of 15% off each purchase.

Mariposa is excited to offer this new program and will be closely monitoring its progress throughout the next year. During this time, we are limiting the number of recipients. We hope to increase program participation beginning in September 2018.

HOW DO I APPLY?

Food For All is open to all Mariposa owners and we are currently accepting applications on a rolling basis. If the program reaches capacity during its pilot year, owners will be placed on a waiting list and will be notified when we are able to accept additional qualifying owners.

Please note, while you do not have to be an owner to shop at Mariposa, applicants must be a Mariposa owner in order to apply to the Food For All program. The Mariposa Owner Fund helps support the equity investment of owners by subsidizing \$100 of the \$200 equity investment and lowering the quarterly payment to \$10 after the first year. Applicants must include a copy of photo ID and one of the following forms of eligibility verification:

- Up-to-date SNAP card - Current Budget Sheet or Legal Notice of Eligibility
- WIC documentation - WIC Card and Current Active WIC Check
- SSI - Current awards letter
- TANF Cash Assistance - Current Budget Sheet or Legal Notice of Eligibility
- Medicaid - Current awards letter

Identification and verification forms can be emailed to ownership@mariposa.coop or included with the Food For All application. **These forms will not be kept on file and will only be used for verification purposes.**

I understand that:

- The FFA discount is valid for one year; I must reapply annually.
- If my FFA discount expires, I will not receive a retroactive discount. Applications can be resubmitted at any time.
- I can separately apply to the Mariposa Owner Fund to receive an equity subsidy and pay equity at a lower rate. If Co-op funds are unavailable, I can still pay equity at a lower rate and must contact Owner Services to do so.
- The FFA discount cannot be shared.
- Certain items such as gift cards and SEPTA key cards are not discounted.
