Insurance certificate shall be provided no less than 30 days prior to the date of the air show.

**Rules and Additional Terms to Agreement**  
**APPLICATION DEADLINE IS MONDAY, OCTOBER 8, 2018**

1. All Vendors must check in at the "Vendor Registration Tent" upon entering the show grounds. Set-Up: Thursday, November 1, 2018 and Friday, November 2 2018, 9AM - 3PM. NO CARS WILL BE ALLOWED ON THE AIRFIELD AFTER 3PM ON FRIDAY, NOVEMBER 3, 2018.
2. Vendor shall confine its exhibit to its own booth. Any questions concerning allowable areas for distribution shall be determined at the discretion of the Stuart Air Show, Inc. Please direct questions of this nature to the Vendor Coordinator.
3. No part of a Vendor display may interfere in any way with other booths, displays, vendors, etc. or reach beyond the limits of the rented booth space. No vehicles are to be parked next to or behind the booth. Vehicles parked beside/behind booths will be towed at the owner's expense. Vendor shall keep booth neat, attractive, and free of debris at all times.
4. Vendor booth shall be manned at all times during the air show hours of 9AM to 5PM both Saturday and Sunday. Vendor booths should not be left unattended. No valuables shall be left at the booth at any time (including before, during, or after show hours).
5. Each registered Vendor will be provided with (6) General Admission Tickets to allow employees/booth personnel admission to the show. Each ticket is valid for one person for one day. Vendor/Vendor/Exhibitor entry tickets are for the sole use of allowing VENDORS and their employees entry to the show. The tickets are not for resale. If you have more than (6) people working in your booth over the (2) day show, you must purchase additional tickets. Tickets are \$15.00 each and must be purchased in advance through the Vendor Coordinator. IF YOU DO NOT PURCHASE YOUR ADDITIONAL TICKETS THROUGH THE VENDOR COORDINATOR IN ADVANCE, YOU WILL BE RESPONSIBLE FOR PURCHASING TICKETS AT THE GATE FOR \$25.00 EACH. Every person must have a ticket to be admitted into the Air Show. Each registered Vendor will also receive (2) Vendor parking passes. Each parking pass will allow you to park one vehicle in the Vendor parking area. Each parking pass is valid for Saturday and Sunday. Due to limited Vendor parking, additional booth personnel must park in General Parking. Tickets and parking passes are not required for set-up on Thursday & Friday during designated set-up times.
6. NO HELIUM BALLOONS are allowed at the show. The show management reserves the right to limit any items from being sold or distributed that may cause potential danger to the aircrafts or spectators.
7. No food or beverage items may be sold or used as give-away items. The show management must approve all giveaways no later than two weeks prior to the Air Show.
8. Use of a generator at your booth must have show management approval no later than two weeks prior to the Air Show. Must place trash in front of your tent at close on Friday, Saturday & Sunday.
9. Vendor waives, releases, and forever discharges The Stuart Air Show, its Vendors, producers, officers, directors, agents, insurers, employees, staff, officials, contractors, vendors, organizers, performers, volunteers, attendees, all other persons or entities involved with the Air Show, (collectively, the "Released Parties"), from any and all claims, causes of action, damages, losses (economic and non-economic), and liabilities of every kind (collectively "Claims"), including, but not limited, releasing all of the above Released Parties from claims stemming from the Released Parties own negligence, for death, personal injury, or property damage, which may arise out of, result from, or relate to the Vendor's assistance/participation in, or traveling to or from, the Air Show, including but not limited to any Claims for theft, damage to any equipment, negligence, partial or permanent disability, Claims relating to the provision of first aid, medical care, medical treatment, or medical decisions (at any Air Show site or elsewhere), and any Claims for medical or hospital expenses. Vendor / Vendor / Exhibitor assumes all responsibility for any and all risk of physical injury or death or property damage that it may sustain while participating in any way, including travel en route to and from the Air Show, in any voluntary effort or activity of any nature, including the use of equipment and facilities of The Stuart Air Show. Furthermore, Vendor agrees to indemnify and hold harmless and defend the additional named insureds, including the Stuart Air Show, Inc., Road to Victory Military Museum, Martin County Airport/Witham Field, all of their officers, directors, agents, employees, and volunteers, from any and all expenses incurred, claims made, or liabilities assessed against them, including but not limited to attorneys' fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, any breach or failure to abide by any part of this Agreement, any of Vendor/Vendor/Exhibitor's alleged actions or inactions which cause injury, death or damage to any other person or property arising from any connection or nexus to Vendor attractions or operations. Vendor agrees that the venue for any action stemming from this agreement will only be in Martin County, Florida and this Agreement shall be governed by the laws of the State of Florida with attorney's fees being awarded to the prevailing party. Also, if any provision of this Agreement shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
10. Vendor acknowledges and agrees to allow any photograph, video, likeness and/or voice to appear in any documentary, promotional (including advertisements), television, radio, electronic or film coverage of the Air Show without compensation or further notice, and agrees and assigns all copyright or other interests therein to The Stuart Air Show.
11. Vendor shall comply with any and all applicable state, local or municipal regulations, laws and ordinances, included but not limited to health, fire, electrical, and revenue.
12. Neither the Stuart Air Show, Inc. nor its officers, agents, employees or representatives, or volunteers shall be liable or responsible for any delays or cancellations beyond its reasonable control such as acts of God, weather delays or government restrictions.
13. Vendor shall not assign to a third party its rights hereunder or hire or use any subcontractors without the prior written consent of the Airshow, which it may withhold at its sole discretion. If such consent is given, the Vendor/Vendor/Exhibitor shall assume full responsibility for the conduct of the assignee/subcontractor and all its representatives, and the Vendor/Vendor/Exhibitor shall not charge its assignee/subcontractor more than a proportionate share of the amounts agreed to under this Agreement. Also, all assignees and subcontractors shall comply with all the duties and terms of this Agreement, including but not limited to the terms of insurance and indemnification.
14. Stuart Air Show will establish hours when the Vendor may enter the Show premises in order to setup, operate or take down the attractions, and will establish assigned attraction and parking areas and reserves the right to make changes. However, such changes will be made as far in advance of the Air Show as possible. Stuart Air Show has the right without penalty to enter the booth or to deny entrance to the show and/or booth to anyone because of their conduct, noncompliance with the aforementioned designated hours, or for life, health or safety reasons and for the best interests of the Air Show.
15. No pets or animals allowed on the Air Show grounds.
