### **Southbound I-205**

Take I-205 to Exit 9, Oregon City. Follow signs to 99E which goes through Oregon City to Canby. Fairgrounds are on the right side (west) of the highway. Turn right, go over railroad tracks, continue straight past the first two entrances. Parking is on the right next to the show grounds by the rodeo arena.

### **Southbound I-5**

Take Exit 282, Canby-Hubbard. Follow directions to Canby and turn right on Grant Street. Take Grant to 99E, turn left and go to north end of town. Fairgrounds are on the left.

### **Northbound I-5**

Take Donald-Aurora Exit, turn right and proceed to Aurora (about 2 miles). Turn left onto 99E, go north through Canby and turn left at Fairgrounds.

- 12 to 18 months: 12 months of age by day of show and under 18 months
- NOVICE: For any dog or bitch of any age that has not won 3 first placements
- AMERICAN BRED: For any dog or bitch of any age born in the U.S.
- BRED BY EXHIBITOR: The exhibitor must be both the owner and breeder.
- OPEN: For any dog or bitch of any age.

## SPECIAL CLASSES (DOGS & BITCHES)

**PUPPY SWEEPSTAKES:** Must also be entered in a regular class, 3 months to 18 months. 50% of class entry fees distributed between the winners of Junior and Senior Stakes.

**JUNIOR STAKES:** 3 to 6 months, 6 to 9 months, and 9 to 12 months classes for each sex.

**SENIOR STAKES:** 12 to 15 months and 15 to 18 months classes for each sex.

**BEST/BOS ALTERED:** A special competition class for the I.W. that is not breeding quality and has been responsibly neutered or spayed. Males and Females may enter. Rosette ribbons will be awarded.

**BEST/RES. BEST OF CHAMPIONS:** Because this is a match and not an AKC show, Champions may not enter competition classes. Male and Females may enter. Trophies to Best and Reserve. Rosette ribbons will be awarded to all.

**PARADE OF VETERANS:** To honor those 6 years of age or older in our short-lived breed. Rosette ribbons will be awarded.

**FRIENDS OF THE IRISH PARADE:** For the special canine friends who live with our Irish Wolfhounds. Rosette ribbons will be awarded.

**PARADE OF FAMILY FRIENDS:** For those Irish Wolfhounds that are not competing in conformation but need to be recognized.

**BRACE/TEAM:** Should be close in size, type and coloring. Need not be of the same ownership. Rosette ribbons will be awarded.

**CREATIVE HANDLING/CREATIVE COSTUME:** Unique or creative presentation.

**STUD DOG/BROOD BITCH:** Must be shown with at least two of its offspring. Submit entry for only the dam or stud. Rosette ribbon will be awarded.

**GENERATIONS:** 3 or more Irish Wolfhounds of direct descent (ie: grandparent, parent, offspring). Need not be of the same ownership. Exhibition only.

**OF GREAT SIZE & COMMANDING APPEARANCE:** Will be measured twice during the day then team judged with special classes. Awards will be offered for Best Dog & Best Bitch

**The following classes may be entered at ringside—no charge**  
Placement only to 1st. Rosette ribbon awarded.

**BEST TYPE:** The Wolfhound that most closely exemplifies the Standard of Excellence

**BEST MOVING:** Movement is an important part of our breed's heritage.

**BEST HEAD:** The best representation of a classic Irish Wolfhound head.
