(hereinafter referred to as "First Presbyterian") and of,(hereinafter referred to as the "Licensee").
WITNESSETH:
Niche: Initial either a or b as applicable
1. First Presbyterian agrees to provide to Licensee the right to the perpetual use of the burial Niche in First Presbyterian's Columbarium, said Niche to be <i>number</i> (s), [INITIALS:] and to provide perpetual care for said Niche. The right to the use of the Niche shall also include the right to have an Engraved Niche Cover placed on the Niche in accordance with the Guidelines as referenced below and attached hereto. The Niche is to be used for the entombment of the Licensee or a member of the Licensee's Immediate Family as described in the Guidelines. First Presbyterian and Licensee each acknowledge that the Niche may be used for the entombment of either one (1) or two (2) persons. a) LUMP SUM PAYMENT - \$2,000: Payment in the amount of Two Thousand and No/100 Dollars
(\$2,000) made by Licensee to First Presbyterian Church, Belmont, North Carolina.
OR
b) PARTIAL PAYMENTS - \$2,300: IN CONSIDERATION of a deposit made to First Presbyterian Church in the amount of Five Hundred and No/100 Dollars (\$500.00) as of the date hereof (the "Deposit") and such other and further consideration as set forth below, the sufficiency of which is hereby acknowledged, and such other mutual promises and agreements set forth herein, the parties covenant and agree as follows:

That the Licensee agrees to pay a Remaining Balance of One Thousand Eight Hundred and No/100 Dollars (\$1,800; hereinafter "Remaining Balance"). At Licensee's option, said Remaining Balance may be paid in three (3) equal annual installments of Six Hundred and No/100 Dollars (\$600) each due on or before March 1st of each year following the date of this Agreement. All outstanding balances must be paid before Licensee may use the Columbarium. All funds are payable to First Presbyterian Church, Belmont, North Carolina. In the event that Licensee fails to pay any annual installment when due or fails to pay the Remaining Balance on or before March 1st of the third year following the date of this Agreement, then Licensee shall have forfeited his, her or their Deposit plus Annual Payments to First Presbyterian Church and shall have no further rights pursuant to the terms of this Agreement.
