## Pavilion and Picnic Site General Information & Rules:

**PERMITS** – Customer must keep rental receipt with them during their reserved time slot for proof of reservations. A permit is only applicable for the date(s), time(s) and location(s) identified on the receipt provided by TGP Staff. TGP Staff reserves the right to remove a permit holder in the event they and/or their attendees are not in compliance of TGP Ordinances, Rules and Regulations. (see separate document for Ordinances, Rules & Regulations)

**AMPLIFIED SOUND** – Amplified Sound is not permitted.

**ALCOHOL POLICY** – Beer, wine, canned beverages and coolers are permitted in Tower Grove Park. Glass bottles of any kind and kegs are not permitted. Public intoxication, public urination and disturbance of the peace are not tolerated. Any persons exhibiting such behaviors will be required to leave the premises immediately, with potential repercussions or expulsion of the Permit Holder. The sale of alcoholic beverages is not allowed.

**DRIVING & PARKING** – Parking is allowed along the public streets inside and around the park. Driving onto grass and/or walking paths is strictly prohibited.

**DECORATIONS** – Decorating is allowed with strings only, no invasive methods to any surface are allowed such as the usage of tacks, staples, nails or tape. Picnic tables are not able to be relocated.

**SPECIAL PERMITS** – An additional permit fee of \$20.00 is required for each of the following items:

- \*Johnny on the Spot \*Commercial Vehicle/BBQ Pit \*Bounce House & Generator \*Carnival Attractions
- \*Food Trucks/Ice Cream Trucks \*Petting Zoo \*Electric Ice-Storage Chests \*Food/Drink Booths
- \*Tents larger than 10'x10' (Contact Event Partner at (314) 729-7776)

Tower Grove Park has an exclusive agreement with Johnny on the Spot. To secure a unit, contact them directly at (314) 863-8874 after securing a 'Special Permit' with TGP Staff must be within 72 hours of event date to allow proper notice.

**RECYCLING CONTAINERS** - Recycling booths/containers are not a requirement of Special Events in Tower Grove Park, however it is extremely recommended. **CANCELLATION, RESCHEDULING & REFUND POLICY** – There are no refunds available once a permit holder has paid in full. The permit holder will be able to re-schedule a rental date, if Tower Grove Park schedule allows within that calendar year. A request to re-schedule an event must be submitted to TGP staff 3 weeks prior to event date to be eligible for a re-schedule. No refunds are given due to inclement weather. No refunds are given for any other circumstances.
