All vehicles that will not be selling out of their trunks must removed from the event area before 8:00am.

Booths must be ready to sell by 8:00am.

Vendors may be open from 8:00am to 12:00pm.

Rules:

1. Beeville Main Street reserves the right to reject any goods that it feels are inappropriate or not representative of the family-friendly festival. **All Booths /Trunks must sell new, vintage or gently loved items. No large Appliances/ furniture will be allowed. (Example: sofas, refrigerators, ovens, etc.)**
2. See above for hours of operation. **Awning/canopy covering is optional.**
Vendors are required to be open from 8am- 12pm for hours of operation.
3. Booth size will be approximately 10x10 or a parking space. Vendors must be pre-approved through the Main Street Department. Space will be provided for pre-approved vendors only. Spots will be on a first come first serve basis for Trunk sale. Farmers Market Vendors will be placed accordingly, on the Depot Pavilion.
4. **Main Street provides space ONLY.** No electricity will be provided. Tables, chairs, tents, lighting and any other accoutrements are the vendors sole responsibility.
5. Each vendor is responsible for his or her own sales tax requirements. Must have Texas State Tax ID.
6. Vendors must keep their area clean and must dispose all trash/items privately.
7. Vendors must not give away or sell any items not previously agreed upon.
8. Booths/ Trunks must be clearly and neatly marked with signage detailing the items for sale.
9. All food booths must show proof of health/food permit. Health permits must be signed and displayed. Please call Sonya Soto at Beeville City Hall to obtain Health Permits 361-358-4641.
10. The City of Beeville reserves the right to restrict any items from sale. Absolutely NO fireworks or poppers are allowed.
11. In case of rain, severe or hazardous weather or any other act of God, there will be no reimbursement for booth fees.
