2) NEA-Alaska Dues for active certified members shall be 1% of the teachers' average salary in Alaska rounded up to the nearest dollar, as of May 1 of the school year preceding Delegate Assembly or \$500, whichever is greater. Dues for active education support professional (ESP) members shall be 1% of the ESPs' average salary in Alaska rounded up to the nearest dollar, as of May 1 of the school year preceding Delegate Assembly or 50% of the certified dues, whichever is lower.

3) Contributions or gifts to NEA-Alaska PACE are not deductible as charitable contributions for federal income tax purposes. NEA-Alaska PACE \$15 (\$11.25 if three quarter time certified, \$7.50 if half time certified or full/three-quarter/half-time ESP) is collected from each member as an annual voluntary contribution to NEA-Alaska PACE. Any member shall have the option to designate the contribution towards NEA-Alaska Member Defense Program, Educational Excellence training, Bargaining Assistance, or to request a refund by notifying NEA-Alaska in writing at the membership office: 4100 Spenard Road, Anchorage, AK 99517. A request for a refund will not affect membership status in NEA, NEA-Alaska or the local association.

4) Dues payments are not deductible as charitable contributions for federal income tax purposes.
