The meeting was called to order at 5:30 and Frank Baldwin opened with prayer. Belinda Moos was thanked for her delicious mac and cheese dinner she brought.

The record of the e-vote approval of January minutes was entered into this meeting's minutes. January 19th Council Meeting Minutes were approved by e-vote on Feb 2, 2017.

Announcements were made:

Church Archives

- A contract was signed with Oregon Historical Society (OHS) and archives have been conveyed.
- OHS is cataloguing and storing the documents.
- Archives are available to church members for perusal by appointment.
- Documents not taken by OHS will continue to be stored at church.
- · A church historian would be helpful.
- Peace will share this information with the church during Moderator's Moment in worship.

Oliver Lecture Committee

- There is no committee at the moment.
- Congregation Member interest for this committee are still being determined.
- Church Council does not appoint members to this committee.

Financial Oversight Committee membership issues were shared:

- Who should be on list to sign checks? It was felt that signers should be church
 members, that they should be folks who are available when the office is open, that
 they should be familiar with the budget in order to know what the checks are being
 written for, and that there should be a sense that some committee members may
 have a potential future role as treasurer.
- Bill Cunitz was unanimously approved as a new member of the committee.
- Ann Narayan was unanimously approved as a non-check-signing member of the committee.

Socially Responsible Investing (SRI) was introduced by Ruth Ann Barrett. She presented her research and findings and distributed a handout. Among her important considerations were the following:

Institutional investing in socially just ways makes a difference.

- So does individual investing.
- If our church is a values-driven investor, we should advertise ourselves as such.
 (It was noted that the church can choose the UCC investment portfolios we put our money into but we cannot make additions or subtractions to what is in a specific portfolio. We can, however, work nationally towards changing portfolio offerings, and towards creating an SRI fund.)
- How can we educate our church family members in their personal investment choices?
- Staff will explore options for education.
- Ruth Ann was thanked for sharing her passion and expertise on this matter.

Ministers' Reports were shared.

- Michael held up his Beloved Community work and reiterated our need for education regarding the possibility of church sanctuary status.
- Elizabeth shared her support of the Facilitators and her work with the Welcoming Ministry group; she highlighted as well her youth leadership, family gatherings, the new story she created for Godly Play, and the up-dated church photo directory now available on-line.

The **Treasurer's Report** included an affirmation of strong financial health, on target with the budget.

- There was a request that OCWM contributions be made quarterly and that this be reflected in the budget.
- It was noted that the Building Fund was to be set up in 2016 with \$45,000 from the Reserve Fund followed in subsequent years with \$45,000 each year. Since this was not done last year, this will require transferring \$90,000 now from the Reserve Fund, \$45,000 for 2016 and \$45,000 for 2017. The Treasurer will do this
- Bill, Al, and Belinda will give their attention to these two matters.

The **Visioning** topic, **Worship**, was introduced by Michael. He offered questions that we need to take time to discuss:

- How does worship serve anyone who attends on Sunday mornings?
- Is our "tradition" relevant and/or important in shaping services?
- Can worship be transformative?
- Who do we want here?

Frank closed our meeting with prayer and we adjourned at 7:30.

Socially Responsible Investing (SRI)



Discussion Paper

First Congregational Church Portland

Goal

From a sustainability perspective and as an advocate, I'm encouraging the adoption of cross-over terms and activities to help overcome the problem of talking to the choir by focusing on building relationships with people who do not share the same bubble, silo, profession, ism, discipline, neighborhood or faith, but clearly have mutual interests.

SRI is an important cross-over opportunity, particularly for individuals with pension and retirement plans (see note 1) and the institutional investors that represent employees - teachers, unions, non-profits, and faith-based organizations who are most likely to share sustainability values of interdependence, inclusivity, resiliency and have a track record acting on behalf of Mother Earth and her children. And there is plenty of evidence that performance need not be sacrificed!

As reported 11/14/12 by Bloomberg, "Hospitals, retirees, pensions, banks and religious institutions used sustainable and responsible investing (SRI) strategies for \$1 out of every \$9 invested in the U.S. at the end of 2011. Total investments guided by such strategies increased six-fold since 1995. More on Performance and SRI here.

2017 Objectives

- begin educating our members on how to invest in a socially responsible way;
- attract the boomers and millennials (see Note 2) to the Church as prospective members;
- show support to the CPC for their commitment around divesting from private prisons (see note 3); and
- partner (see note 4) with organizations who are active in SRI and have skills and expertise in this area. (see note 7)

Divestment Education

Private prison divestment as a search term does not have enough data to show up as a trend just yet, but it presents an opportunity to join with the divestment movement focused on fossil fuels and for the FCC community to be a leader in expanding the category to include private prisons. (see note 5 for SRI groups and note 4 for investing in equality)

One way to lead, after making sure the organization is walking the talk, is to educate (seminar series) both individuals and institutions on looking more closely at

- why portfolios should reflect the values and beliefs of individuals and organizations.
- using an economic tactic to support both environmental and social advocacy, and
- identifying Portland's faith-based organizations who are joining with the investment community around socially responsible investing, often as part of a sustainability initiative, and more recently, under the banner of climate justice, another cross over term (see note 6 on Faith and Climate justice)
 - how to do it, both individual and organizationally.

Resources - Voices of SRI

As background, there are 15 videos on EarthSayers.tv in the special collection, Investing and Sustainability, and in that collection is a video, What is Fossil Fuel Divestment by The Guardian, The Rise of Responsible Investment by James Gifford, and in the climate justice special collection, CEO Tim Brennan of the UUA how investments match their values. The video content in EarthSayers.tv, voices of sustainability collections has been curated for relevancy and quality.



April 2017

Ceres sponsors an annual event which is April 26 and 27th (2017) in San Francisco. I'm going to pursue getting a press pass as EarthSayers.tv to cover the conference. There may be someone in our Church who might want to represent the Church. I will be doing interviews of people attending the conference and will focus on those folks who address sustainability, climate justice and other categories of divestment such as prison prisons.

The <u>Ceres conference</u> is an opportunity to cross-over, so to speak, and influence a choir of institutional investors such as UUA's Tim Brennan did at the 2013 Ceres conference.

Notes

Note 1

This email references the New York Times <u>article</u>, Nonprofit Employees, Already Underpaid, Face Special Challenges in Retirement, which addresses the work of Mary Brunson. "Her cause is the tens of thousands of diocese employees who are saving money in workplace <u>retirement</u> plans. That issue may not have attracted a lot of attention, but it is a serious problem nonetheless. That is because many of the plans not only cost too much, they also invest in companies that do not align with the church's values. Ms. Brunson spends her days tracking down local church officials, one by one, trying to persuade them to do things differently.

Choi says the study found that about **84 percent of millennials** were interested in sustainable investing. "Really significantly, they're also twice as likely to invest in a stock or a fund if sustainability is part of the value-creation thesis," Choi, 49, says in an interview at Morgan Stanley's New York headquarters. That's only going to become more prevalent over time, she adds. "If you look at the trends of transfer of wealth to women and millennials, it's very striking."

Note 3

I thought a good place to start a conversation around SRI at our Church is the CPC's call "to encourage its church members, congregations and conference Finance Management Working Group to prohibit any and all persons acting on their behalf from entering into any financial relationships with private prison companies and their million shares club investors, and to divest of any existing holdings in the Corrections Corporation of America, the GEO Group, as well as those institutions owning over 1 million shares in these companies.

Note 4

Trillium Asset Management, a Portland based for benefit corporation or B corp, and a leader focused exclusively on sustainable and responsible investing, has a new white paper, Investing in Equality: Integrating LBGT issues into Total Activation, (download) a topic of interest I am sure to both present and prospective members. They also have papers on Extracting Fossil Fuels from Your Portfolio and Fossil Fuel Free Investing at Trillium. B Corporation "provides a framework and certification for companies wishing to benefit society as well as their shareholders."

Note 5

Three organizations of interest are <u>Ceres</u>, <u>earth folio.net</u>, <u>The forum</u>.

Note 6

Climate justice is another important cross-over term addressing three communities - money folks, climate scientists, and community activists organized around the environmental challenge of climate change (e.g. biodiversity, global warming, wildlife conservation) and its growing impact on the social justice landscape to include groups such as Black Lives Matter and Standing Rock. It connects the business functions/issues of SRI, Environmental Sustainability, Corporate Social Responsibility (CSR), and ethical supply chains.

Presently exploring <u>Faith and Climate Justice</u> from the perspective of increasing awareness of climate change by addressing these broad objectives over the next three years (time running out):

- (1) moving a majority of the faithful in the U.S. to being concerned and alarmed about climate change **and willing to support public policies** that restrict carbon emissions and the use of vehicles, a large source of US global warming emissions;
- (2) reframing with faith-based organizations climate change to climate justice, an ethical and moral issue;
- (3) framing global warming as the mission critical social, environmental, and economic issue of the sustainability movement; and
- (4) launching a Call for Climate Justice by alarmed and concerned leaders through their churches and spiritual organizations.

Note 7

For example, in December of 2014, Portland's City Council passed a resolution creating a Socially Responsible Investments Committee. The committee is charged with recommending corporate issuers for inclusion on, or removal from, the City's Corporate Securities Do-Not-Buy List in the City's direct investment in corporate securities."
