- 7% left high school without graduating

Overview

Since 1981 the Lambert House LGBTQ Youth Center has cared for, championed, and celebrated over 14,000 individual minors and young adults in the Greater Seattle Region through over 500,000 direct, inperson service contacts. The Center was founded to address health and mental health disparities faced disproportionately by LGBTQ+ youth. Its employees and 123 skilled volunteers provide support in 10 locations for more LGBTQ youth than any other organization in the Northwestern United States. Lambert House is the only social service agency in Seattle and King County (Pop. 2.25 million) dedicated solely to LGBTQ+ youth. In addition to Seattle, rural and small-city service locations include: Algona-Pacific, Carnation, Covington, Enumclaw, Fairwood, Lake Forest Park, Maple Valley, Snoqualmie, and Vashon Island. In 2019, 1,317 youth were supported through 33,000 direct in-person service contacts. Seventy percent (70%) of the youth were minors, ages 10 through 17.

Lambert House delivers programs, services, and global advocacy that span eight categories: 1) Social Connection, Peer Support, Resilience, and Self-Esteem Building; 2) Family Success, Bullying Resistance and School Retention; 3) Mentoring; 4) Homeless Services including Meals, Clothing, Personal Hygiene Items, and Referrals; 5) HIV and STI prevention and Healthy Relationships Education; 6) Culture, Sports, and Outdoor Recreation; 7) Workplace Skills Development, Youth Leadership, and Academic Internships, and; 8) Systems Change through Training for Licensed Professionals and Governmental and NGO Leaders from around the world.

In March 2020 Lambert House pivoted its programming online due to Covid-19. As of May 2021, online programs serve youth living in 26 U.S. states and five countries. Programs are staffed seven days per week. Five software platforms and 19 programs meet the technology access needs and diverse interests of LGBTQ+ youth.

Lambert House programs are evidence-based and employ positive youth development, and adult and peer social support, as protective factors to minimize the documented health and mental health risks that LGBTQ+ youth face including: Family or peer rejection that can lead to depression, homelessness, or suicide; using alcohol and other drugs as coping mechanisms that can lead to addiction; anti-gay bullying in school that can lead to skipping classes and a disproportionately high rate of school failure; high rates of smoking and risk-taking behaviors due to minority stress and low self-esteem, and; homelessness that can lead to survival sex and HIV.

In one indication of program efficacy, LGBTQ+ youth have actively sought, participated in, and returned to Lambert House's online programs more than 6,000 times during the Covid-19 Pandemic.

Lambert House is a force against bigotry and in the struggle to build a world in which LGBTQ+ children and young adults are healthy and command equality in their families, schools, and communities.
