On July 1, 1805, Robert Akers granted land to James Todd, which was conveyed by said Todd to Alexander White on February 2, 1810. It was from this land that Bethel was deeded about seven acres by Alexander White in 1845 to build its new church.

**WILLIAM TODD SR.** (b. Dec 13, 1789 County Antrim, Belfast, Ireland—d. Sept 12, 1875 Oconee Co., SC.), *the son of James Todd and Jane Erskine*, married **MARY BOLTON RICHARDS** (b. July 16, 1796—d. Jun 16, 1880 Oconee Co., SC), *daughter of Thomas Richards and Elizabeth Page*. Children:

- (5) William Augustus Todd, b. 1827 Pickens Dist., SC—d. Aug 6, 1862 Richmond, VA, in the war; served in Orr's Rifles [died Aug 3 according to his service record]; m. Oct 1, 1857, to Sarah Ann Hembree, b. 1840 Pickens Dist., SC—d. Mar 3, 1909 Knox Co., TN, *daughter of Edward Hembree and Elizabeth Sanders*; Sarah served as a field nurse in the mountains of western North Carolina during the war;
- (6) John Newton Todd, b. Jan 9, 1831 Pickens Dist., SC—d. Nov 12, 1910 Oconee Co., SC; served in Co. E, Orr's 1<sup>st</sup> Rifles; m. Aug 17, 1865, to Fannie Clarinda George, b. June 23, 1840 Pickens Dist., SC—d. Apr 21, 1891 Oconee Co., SC, *the daughter of James George and Mary Telford*;
- (7) Mary Caroline Todd, b. Mar 1, 1832 Pickens Dist., SC—d. Dec 14, 1918 Oconee Co., SC; m. Robert Hiram Cowan, b. Oct 18, 1834 Pickens Dist., SC—d. July 14, 1932 Oconee Co., SC, *son of Robert Cowan and Philopena Sharp*; and
- (8) Laura Elinor Todd, b. Dec 16, 1835 Pickens Dist., SC—d. Apr 25, 1913 Anderson, SC; m. Rev. Andrew Phillip Nicholson, b. June 16, 1832 SC—d. Mar 24, 1890 Anderson Co., SC; served in Orr's Rifles during the war.

- (4) David H. Todd, b. 1839 Pickens Dist., SC—d. Jun 27, 1862 at home from wounds at Gaines Mill, Hanover Co., VA; served with Co. E, Orr's 1<sup>st</sup> Rifles;
- (5) Thomas Cater Todd, b. 1842 Pickens Dist., SC—d. Thursday, Sept 27, 1916 Oconee Co., SC; served with Co. E, Orr's 1<sup>st</sup> Rifles; m. Anna Duncan, b. May 3, 1846 Anderson Dist., SC—d. Mar 22, 1912 Oconee Co., SC, *daughter of David Duncan and Nancy Trotter*; and
- (6) Martha Ann Todd, b. Aug 22, 1847 Pickens Dist., SC—d. Feb 12, 1888 Oconee Co., SC; m. Oct 1, 1867, to James Andrew Bell, b. Oct 5, 1841 Pickens Dist., SC—d. Jan 8, 1904 Oconee Co., SC, *son of John Milton Bell and Arah Beck Swafford*.
