## **RECAP, JANUARY NWSCC MEETING:**

Our special guest speaker was **John Reinhardt**, a CPA who served as the NWSCC treasurer for a number of years. John spoke to us about **new IRS reporting requirements for tax exempt ski clubs starting with tax years beginning in 2008**. This is an extremely important topic for all of our member clubs which are nonprofit IRS 501(c)(7) "social clubs," and the information should be shared with all club officers, particularly your treasurers! A full version of John's handout will be posted to the NWSCC website and can be printed directly from the website for discussion at your ski club board meetings.

**Not all income of a tax exempt organization is exempt from tax.** For a ski club, membership dues and income from club members participating in club activities (e.g. ski trips, parties, and other such functions) are exempt from tax. However, investment income (e.g. interest income) and unrelated business income (e.g. revenue from advertising in a club publication) are subject to tax if the combined total exceeds \$1,000 in a year. **The IRS has substantially changed tax exempt entities' reporting forms and requirements for 2008.** There are now three reporting levels, and your reporting level is determined by the amount of total gross receipts your club has during the tax year.

"Gross receipts" are generally your total deposits, not counting transfers between accounts. This includes the

total receipts from running trips or other activities, without reduction for the costs of putting on those activities. You need to file Form 990-N if gross receipts are not more than \$25,000 in 2008 and 2009, and \$50,000 in 2010 and later years. You must file Form 990-EZ if gross receipts are not over \$1 million in 2008, \$500,000 in 2009, and \$200,000 in 2010 and thereafter. You must file Form 990 if your gross receipts exceed the limits for filing Form 990-EZ. *In addition*, if you have combined investment income and/or unrelated business income in excess of \$1,000, you are required to file Form 990-T.

**Penalties for not filing:** All organizations that fail to file their required 990 forms for three consecutive years will lose their tax exempt status. Once tax exempt status is lost, the organization will have to go through a new application process to regain tax exempt status, and there is a fee involved in doing this. There are penalties to the organization for not timely filing a required Form 990-EZ or Form 990. The penalty is \$20 per day (\$100 per day if gross receipts are in excess of \$1 million). The IRS will send the club a notice of failure to file, and if a return is still not filed, than the responsible person(s) within the club will be subject to personal penalties of \$10 per day.

**Due dates for filing:** The due date for filing tax returns is the 15th day of the fifth month after the club's year end (May 15th for clubs using a calendar year). The IRS will grant an automatic 3-month extension if you timely file Form 8868 to request an extension. You may also apply for one additional 3-month extension. In doing so, you have to provide them with a reason as to why you need the extension, and you must be prepared, as they may deny it.

NWSCC is in the process of planning a **30th Anniversary party** this year. We are discussing a September or October event which will be FUN, as well as showcasing our member clubs and their histories. Watch for further details.

Speaking of **club histories**, NWSCC encourages all its member clubs to organize and prepare their club histories to help celebrate! We will provide display space at the anniversary party, and the Mt. Hood Cultural Center and Museum has a club history room where your club could maintain a permanent record of its history. Our **Council Historian Norvin Peer** will work with you on your submissions - contact Norvin at 1-360-430-4546, or send information to Norvin at 1510 Ocean Beach Highway, Longview, WA 98632.

NWSCC is taking names from its clubs for their **Man and Woman of the Year** nominees, and will vote upon the NWSCC Man and Woman of the Year in March. Please bring a short paragraph about your winners to the March NWSCC meeting. The NWSCC winners will be entered into competition at the FWSA Convention in June, and if they are present at the Convention, each will receive a 2-day trip for two to Big White/Silver Star, BC, Canada! The overall winner at the Convention receives a 5-day trip. The criteria for the FWSA Man and Woman of the Year include lifetime achievement, involvement in club, council, and FWSA activities, as well as charitable activities, and the number of areas skied. These criteria are not used to judge the NWSCC winners.

**The American Cancer Association is sponsoring a special event at Mt. Hood Skibowl on March 20-21, 2009 called Hope on the Slopes.** This is a vertical foot challenge, and individuals or teams will be skiing for 24 hours trying to get the most total vertical feet. Prizes will be awarded based upon both the vertical feet skied and the fundraising accomplished. A team entry is only \$150 for 5-15 team members (which is a better deal than the \$35 individual registration fee). Discount lift tickets will be available for \$35. Each participant and team receives a personal web page to assist in its fundraising efforts. See attached flier or check out the website at [www.oregonhopeontheslopes.org](http://www.oregonhopeontheslopes.org) - the event happens at several Northwest ski areas, as well as other areas in the country. Proceeds will support the work of the American Cancer Society. This event will be featured at the regular NWSCC meeting on Feb. 18.

## CLUB INFORMATION:

NWSCC member clubs are welcome to sign up with Sheri Parshall to present a brief history of their club at upcoming Council meetings: so far Cascade and Skiyente have asked to be on the agenda. We are asking member clubs to start assembling their history for presentations, to consider preparing to enter FWSA's club history competition, and to think about possibly setting up a permanent record of your club at the Mt. Hood Museum and Cultural Center in Government Camp!

The **Mt. Hood Cultural Center and Museum** has "Après Ski" events on the second Saturdays: Skiyente will be the host on February 14, and the Oregon Nordic Club on March 14. Think about this for next year - the Museum will put your club in touch with a winery for beverages, and the club should plan to provide hors d'oeuvres and showcase their club. Clubs or organizations are invited to join the Museum for annual dues of \$100. This allows the

organization to use Museum facilities for scheduled events without paying the usual \$400 facility charge. Individual memberships are \$20, and family memberships are \$35, and help support this very worthy facility. They have raised \$75,000 towards their "elevator" fund that will bring them into compliance with ADA laws. Contact Sheri Parshall for more information on the Museum.

**Skiyente's King Winter Dance** will be held at Charlie's Mountain View in Government Camp on February 14. They have announced this year's King Winter to be **Jack Nantz**.

**Lectures at Mt. Hood Museum: Avalanche Awareness 101** will be held **February 21 and March 21, 2009**, at 7:00 pm. This free class is presented by Roland Emetaz of the Northwest Weather and Avalanche Center, and Jim Thorten of the U.S. Forest Service. Find out how local terrain, snow cover, weather, and human factors all contribute to avalanche danger. Learn what clues to look for, gear to take, routes to follow, and what to do if you or your companions are caught in an avalanche.

**Ski The Historic Glade Trail Day - March 7, 2009** - Annually on the first Saturday of March, by special permit from the Mt. Hood National Forest, the Glade Trail is opened and groomed for this living history event. This full day event is a chance to experience a historical way of skiing on Mt. Hood. Skiers are shuttled to Timberline Lodge by bus, and escorted down the 3.0 mile trail to Government Camp by local guides and the Mt. Hood Ski Patrol. Lunch, Après ski party and prizes are included in this unique fundraiser. Participation is limited to 75 people, and always sells out. Event tickets are \$100.00 per person; reserve tickets by calling 503-272-3301.

**Altair Ski Club** has a very full schedule of events, too numerous to mention here.
