### **RECAP OF JULY NWSCC MEETING:**

Watch for further details on the NWSCC Ski Fair to be held November 9, and a NWSCC ski trip to Utah to be held in early December. The 2010 Bachelor Blitz trip is tentatively planned for April 16-18, the weekend after the FWRA championships in Mammoth (April 9-11). The council is planning a trip to Mammoth for that event, assisted by Beth Paraskeva of PACRAT. Mammoth and Horizon Air are working on a proposal to create a \$39 one way ticket from Reno to Mammoth, which would be faster and cheaper than bus transportation currently available. Everyone will be welcome, racer or not, to join us and ski this incredible mountain - it's not named "Mammoth" for nothing!

Ideas were discussed for topics at future meetings, as well as potential educational opportunities for club members. Some of the ideas suggested were:

- \* Having a "newsletter night" with a presentation on newsletter editing or one on website creation and maintenance. It was suggested that clubs could parcel out writing articles for the newsletter to more than one member, and to solicit corporate sponsors at the club level.

- \* Trip planning, including how to be a good participant on a club trip.

- \* Backcountry safety, including avalanche danger and preparedness, the costs of going out of bounds if you need rescue, statutes, and life flight insurance.

- \* The impact of new legislation on Mt. Hood recreational activities - possibly a presentation from the Forest Service.

- \* ODOT - the Oregon Department of Transportation - road information, snow park permits and plowing, and our responsibility as recreational participants. Access to Mt. Hood Meadows in the event of another washout.

- \* An "injuries" discussion night - safety aspects and lessons learned.

Sandi Shaub gave a report on the status of the lawsuit filed by Women's Ski Jumping USA against the Vancouver Organizing Committee for the 2010 Winter Olympics. While the court ruled there was discrimination in not allowing the women to compete, it was a hollow victory, as the court also concluded that it had no authority to enforce its decision.

Barbara Bousum reported that we have now received our lodging assignments for the **FWSA Ski Week in Keystone, Colorado, January 30-February 6, 2010.** Everyone will be staying in condos away from the base of Keystone, but with easy access by a short shuttle ride. Participants will book their own air, and ground transportation will be arranged. A 5-out-of-7 day lift ticket will be interchangeable among Keystone, Breckenridge, and Arapahoe Basin, and also includes 2 days good at Vail or Beaver Creek. If a 6th day of skiing is desired, it can be obtained for only \$30 if booked in advance, or \$60 on the trip. Of course the price will include the usual races, parties, and dinner. The banquet dinner will be held Thursday night instead of Friday so that it will be easier for people to pack for departure on Saturday. The event includes a hosted welcome party, 3 days of races, and a Cocktail Awards Reception and Awards Dinner Banquet, all for the price of \$195 (lodging and transportation not included, but packages are available). **ITEMS FROM JULY FWSA NEWS:**

**Marmot Basin** is building the longest high speed chairlift in Alberta's Canadian Rockies—a 2.3 km long (almost a mile and a half) high speed quad chairlift—this summer. It will rise almost 2,000 vertical feet in just over 7 minutes.

**Yellowstone Club Sold**—Boston based CrossHarbor, a private equity company, has purchased Montana's Yellowstone Club, a private ski resort open only to millionaires that is linked to the neighboring Big Sky and Moonlight basin, creating arguably North America's largest lift-linked ski areas. The new owners say that existing agreements with club members will remain in force.

**Airline Fees Big and Getting Bigger**—United Airlines has

increased its checked baggage fee to \$20 for the first bag and \$30 for the second bag. However, if you pay the bag fees online, you get a \$5 discount -- or back to their original price for checked bags. The airlines began charging bag fees after the price of oil skyrocketed and they're still trying to recoup their losses. It's working very well so far (for THEM), as the airline industry collected \$1.1 billion on checked bag fees last year.

**Vermont Seeking Back Sales Taxes on Ski Share House Rentals**—With the down economy, some states are straining to find more income sources. Here's one of Vermont's "solutions" (which they claim to have been pursuing for over a decade). According to a Rutland Herald article dated May 8, 2009, The Vermont Department of Taxes has sent tax bills to ski-share house renters for thousands of dollars each. The tax department's compliance division began issuing notices to both homeowners and lessees of private ski shares in Killington in late April—saying that they must register as a business so they can be billed the state's 9% meal and room taxes.

**Competitive Core Training**--Learn how to train like the US Ski Team using a method called the Competitive Core Training. Competitive core training is essential to build strength in the torso.
