Arts and Crafts Vendor Information – Juried Show

Location: Historic Blanco Town Square, Blanco, Texas 78606

Dates & Times: Friday June 8th, 2018 Noon – 6:00 pm
Saturday June 9th, 2018 9:00 am – 6:00 pm
Sunday, June 10th, 2018 10:00 am – 4:00 pm

Booths must be open and staffed during the hours of operation listed above.

Move-In: Friday June 8th, 2018 8:00 am – Noon
No late check-in will be allowed on Saturday. Off-duty police will be on-site both Friday and Saturday evenings.

Move-Out: Sunday June 10th, 2018 4:00 pm – 8:00 pm
No tear-down may begin prior to 4:00 pm on Sunday. Items left after 6:00 pm Monday, June 11th, 2018 may be subject to towing and storage charges.

Grounds: Held in downtown Blanco on the Old Blanco County Courthouse square.

Eligibility: Open to individual artists and craftspeople presenting original works. A small, select group of manufactured, imported or resale items will be allowed in the arts and crafts area; however, only those of the highest quality and in keeping with our festival’s standards will be considered. Demonstrating your art or craft, while not required, is considered a bonus. To maintain the quality and balance of the arts and crafts shown, this is a juried show. The Blanco Chamber of Commerce reserves the right to reject any displayed merchandise that is not in keeping with the examples submitted to and approved by the jury. No items bearing the words “Blanco Lavender Festival” and/or “Lavender Capital of Texas” or its logos will be allowed without the prior approval of the Blanco Chamber of Commerce.

About the Jury: A qualified panel of people will judge the photographs you present for consideration. Please be sure to submit clear pictures that accurately portray your work.

Registration: The registration fee will be \$275.00 per 10’ x 10’ space for the three-day show. There will be no price limit on your items sold, and no commission will be taken. All registration forms must be completed and accompanied by a minimum of 4 photographs and a check, payable to the Blanco Chamber of Commerce. We prefer checks, but credit cards and cash are also accepted. Your photographs will be kept on file and will not be returned. Your payment will not be processed until you have been accepted into the show, and your check will be shredded (or your credit card not charged, if you have provided us with this form of payment) if you are not accepted. **The deadline for application is March 2nd, 2018.** There are a limited number of spaces. Please apply early!

Booth Spaces: 10’ x 10’ open spaces are provided. You provide your own canopy. **Canopy corners must be secured by weights, as tent stakes are not permitted on the courthouse grounds.** Electricity will be available on a strictly limited basis, at an additional charge of \$25.00 per space. **Please note: electricity may be used for fans, basic lighting, cash registers, and credit card machines ONLY. No generators or pets are allowed.** If you have previously participated in our Lavender Festival Market and request a specific space, every effort will be made to honor your wishes. Booth spaces cannot be transferred to another vendor without written approval from the Blanco Chamber of Commerce. Booth sharing is allowed, provided that all parties involved are represented on your application form and in your photographs, and are accepted by the jury. All vendors must have sales tax certificates posted for inspection upon demand.

Website Listings: A listing on our Lavender Festival website with your name, company name, a brief description of your merchandise, and a link to your website is available for \$20.00 per business listing.

Notification of Acceptance: You will be notified of your acceptance no later than April 6th, 2018. Please note: there will be no refunds after acceptance and no refunds should bad weather or illness occur.
