TOM MASON ANNOUNCES HIS RETIREMENT



A child of post-war blue collar parents, he was raised on a dairy farm (his dad's hobby) that got out of hand and grew to nearly 100 head. Since his father maintained his factory position the farm became a busy place for his siblings. As the 5th of 6 children he was blessed with an older brother that had an unbelievable ability to understand, evaluate, and repair the second hand equipment necessary to operate the farm. Common for the day, he attended all 13 years of public education at the same rural school. Although his high school performance was academically unremarkable (too much farm work was the weak excuse), socially he encountered a young lady at a skating rink on a cold February night that subsequently became "significant."

During that time period, two other events were of note. A tornado 5 weeks before high school graduation damaged the farm beyond repair. Several cattle survived but the buildings didn't. Being in a building during its collapse instilled in him a new appreciation for structures, nature, and the uncertainty of life itself. The other event was entering a Division 1A university (hockey) in the northern-most reaches of the upper peninsula of Michigan—"Michigan Tech." At the time, enrollment was 5000 students—nearly all engineering, and nearly all men. At that time, those not in college were classified 1-A and immediately drafted to serve in Viet Nam.

After two years of college came marriage. After three came his older son. Upon graduation in Civil Engineering, a structural engineering job was taken in down-river Detroit while his wife continued her Bachelor's degree where she began 4 years earlier. A few months after her graduation a second son was born. A few months after that Mr. Mason started graduate school at Western Michigan University pursuing a Masters degree.

His first professorial experience was at Ohio University where he completed a contract for a faculty member who was on medical leave. While there, he responded to many advertisements for university teaching positions posted in college faculty publications. One of these positions was from the Herff College of Engineering at Memphis State University. Soon after becoming a faculty member, Mr. Mason attended several local CSI meetings as a guest of Dr. Stephen Langa the

coordinator of the construction program at that time. He did not become a CSI member then because he was assigned by the department to be the advisor of the construction student organization (AGC) and was encouraged to become involved with the state professional surveying organization (TAPS). Conflicting meeting times between these three groups restricted his involvement in CSI for many years.

Preceding the formation of the Architecture Department at the university, Mr. Mason took on the duties of a retiring professor of structures. At the same time he learned that Technology's construction program was being phased out. These changes initiated his opportunities to become part of the architecture program before it transferred away from the College of Engineering. When the program began the move toward its own department, he was eager to become involved with CSI Memphis and become the advisor to the student chapter. The position provided many fond memories along with an occasional disappointment. As new student members joined each new academic year, his greatest challenge of advising remained—give advice, not directives—to their ideas, decisions, even when eagerness overshadowed practicality.

Along the span of 38 years at the university, Mr. Mason taught 21 separate course titles concentrating in his early years in Industrial Materials, Surveying, Construction, and Architecture courses. He was also lead professor for several support courses for manufacturing, computer, and electronics majors in the Engineering Technology Department. During the mid 80's he was contracted to teach courses in nuclear power plant materials for nuclear plant control room operators at Clinch River Nuclear Plant and Watts Bar Nuclear Plant for TVA; and the Enrico Fermi Nuclear Power Generator for Detroit Edison. He also presented one-day seminars for professional organizations in topics such as Number Theory, Hydrology, and Facilities Engineering (for the death-care industry). In his later years at the university he concentrated in teaching courses in Building Construction Methods and Materials, Engineering Mechanics, Structural Steel Design, and Structural Concrete Design. He was awarded the Department of Art Distinguished Teaching Award and well as the University Distinguished Teaching Award.

Mr. Mason decided to retire at the end of the 2011 academic year. His post-retirement plans include: complete construction of a new home in Tipton County at the request of his "significant" other. With one son—a doctor living in Ashville NC and the other—a corporate scheduler for Flintco Construction Company in Tulsa OK, granddaughter visits to both locations will require significant travel time. He will also rekindle his structural engineering and professional surveying consulting practice. To complete his bucket list, his property north of Memphis is already zoned to allow for construction of a large farm pond and a private air strip. Should he remain in good health, he plans a second trip to Alaska on the same motorcycle he used to make the first trip with his wife in 1992.

MAXIMIZING MEMBERSHIIPS



Dennis Elrod, AIA, CSI

Dennis was born in southwest Michigan to a blue collar factory worker and a seamstress who uprooted themselves from Middle Tennessee after WWII in search of jobs. His father worked at the Bendix Corporation and his mother at Simplicity Pattern. The middle child of 3, forced his mother to become a full-time mother. At the age of 9, his parents divorced, and Dennis moved to Miami, Florida with his Mother, older Brother, and younger sister, where a maternal uncle helped get them back on their feet. The family was uprooted again at the end of that 4 year stint and ended up in Murfreesboro, TN to help take care of his maternal grandmother until she passed away. Finally 4 years later, the family settled in Tullahoma on the family farm where his Mother was raised. While in High School, he played drums in a 60's garage band with his older brother and friends, learned to play piano by ear, a little guitar, was a runner, and played tennis. In those days, his nickname was "Skinny Denny".

Upon graduation from High School, Dennis knew he wanted to be either a mathematician or an architect. He attended Motlow State Community College to get Math, English and Science out of the way, worked a full-time job at a local wholesale grocery warehouse, and also part-time job at United Parcel Service. He purchased his first car, a turquoise and white 1959 Ford Galaxie Fairlane at age 15 when a church family moved out of state. He gained an interest in muscle cars shortly thereafter and has owned a 1964 Ford Falcon, two 1968 Camaros, a 1965 Chevy Nova and a Pontiac Trans Am.

A twist of fate brought Dennis to Memphis in the Fall of 1974 after having enrolled in the Architecture Program

at UT Knoxville. He fell head-over-heels in love with a young tennis player from Tullahoma whose family had to attend Memphis State University as it was a family legacy. He transferred to Memphis but the relationship soon fizzled. He decided to stay at MSU and finish his BSET degree, graduating Cum Laude in 1977. Upon graduation from MSU, Dennis re-enrolled in the Masters degree program the following year and graduated with an MSTE degree, with Honors in 1983.

After his graduation in 1977 jobs were scarce and Dennis went to work for Clark, Dietz and Associates, where he became a Civil and Structural Draftsman, gaining practical experience in surveying (thanks to Mr. Mason for the basic training), and obtained his CET certificate becoming a successful process piping designer. In 1979, upon the firm's merger with Caudill Rowlett and Scott (which closed the Memphis office), Dennis went to work for Hall & Waller and Associates where he interned for 3 ½ years. In 1982 he made a career change and joined Hnedak Bobo Gooch and Associates and the rest is history. Dennis will celebrate his 29th year at HBG this Fall.

Dennis is married to Leigh Ann Blakely, a Licensed Clinical Social Worker with Baptist Trinity Hospice, has a 15 year old son Joseph, who will be a Sophomore at White Station, and a 12 year old daughter, Elizabeth, who will be a 7th grader at Grace-St. Luke's Episcopal School. He and his family live in the Evergreen Historic District in their 2nd home which he was able to design in the midtown I-240 Redevelopment Corridor. He enjoys golf, flying, scuba diving, racquetball, tennis, volleyball, fly fishing, playing bluegrass banjo, and is starting on a 1963 Ford Falcon conversion to a street machine with his son. Dennis' latest hobby for the past 4 years is Director of Set Design and Construction for Grace-St. Luke's Theater Arts Program. The Elrods are members of Lindenwood Christian Church and volunteer for various charities, hospice and school events.

Most detailed requirements come last in spec sections, & do not govern anything preceding them

Division 01 sections expand on general administrative provisions of conditions of contract & apply broadly to common administrative & procedural requirements of all of other sections of specs. Specs and drawings further expand on Division 01 & provide detailed requirements for specific portions of work.

RELATIONSHIP OF DIVISION 01 WITH DIVISIONS 02-49

Division 01 addresses common administrative & procedural requirements of spec sections to avoid having to repeat same procedures & requirements in each section Requirements specific to specific product of section addressed in that section
