# “Town & Country” Art Exhibition

November 2—January 5, 2019

Our theme offers many possibilities for capturing the small town and rural life. Checking out a library book, the mail delivery, morning coffee at the café, school bus drop off or tractor and hay wagon in the field. The exhibit is open to all artists 18 and older; original 2-D art **only**. Work should be for viewing audiences of all ages.

**Location:** The art will be on display on the first floor of KSB Commerce Towers, 215 E 1st St, Dixon, IL 61021. Visitors to Commerce Towers will have the opportunity to vote for their favorite art piece during the exhibition by voting on a special KSB website page. The winning piece will be featured following the exhibition. The winning piece will be announced at the Chamber of Commerce (BAB) Business After Business Reception, at Commerce Towers in December.

**Fee:** The non-refundable jury fee is \$35 for TNPS members, \$50 for non-members. Each fee allows you to submit up to two (3) entries.

**Specifications:** The maximum total size should not exceed 36”H x 48”W.

**Framing:** Accepted work must be framed and/or equipped with proper hanging devices. NO SAWTOOTH HOOKS.

**Delivery & Pickup:** All work is to be delivered to and/or picked up at TNPS.

**Submissions:** Images of work may be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen.

**Online:** Images must be in JPG format. The entry form may be scanned or the information emailed to nps@grics.net. Payment may be made online via PayPal (nps@grics.net) or credit card.

**Mail:** Send application, payment and materials to The Next Picture Show, 113 West First Street, Dixon, IL 61021.

**Insurance and Liability:** Artists are responsible for insuring their work. A locking device will be part of the hanging system. Neither KSB or TNPS provides insurance or special security on the premises.

**Sales:** Exhibited works will be considered for sale at the price indicated during the submission process. Works not for sale must be designated “NFS”. Only **accepted** work is allowed for the exhibition. No substitutions. All work is to remain on display for the duration of the show. TNPS reserves the right to refuse any work damaged or deemed too fragile.

**Delivery & Return:** Accepted work may be shipped or hand delivered to TNPS at 113 W. First St., Dixon, IL 61021. Hours: Tuesday—Saturday, 10:00am—4:00pm. Please attach the following information to the back of your work: name, title, medium, and price.

**Publicity:** TNPS reserves the right to video or photograph all work for publicity purposes.
