Neither the Neighborhood Association nor the Architectural Control Committee shall have any liability to any Contractor or lot owner with respect to the construction of and materials used in any building on a lot within the plat. It shall be the Contractor and lot owner's sole responsibility to obtain all permits for the construction of any improvements on a lot in the plat.
