Pro Bono

Pro Bono work is an excellent way to gain valuable practical experience in law. It enables you to apply and develop your legal skills for the benefit of the public good. From panel discussions with Pro Bono coordinators and presentations by charitable organisations addressing justice issues, to court support training programmes. Our Pro Bono officer, **Genevieve Douglas**, is committed to providing you with a range of opportunities to learn about, and take part in, Pro Bono legal services. Some examples of these opportunities are:

Aspiring Solicitors

Also known as just AS, Aspiring Solicitors is an employability platform for students from underrepresented backgrounds entering the legal profession. Their aim is to help students through the application process to law firms and other companies. There is a range of assistance offered to members such as workshops, interview advice, researching skills and preparation for assessment centres.

Aspiring Solicitors also runs **mentoring schemes (AS First, AS Aspire and AS Headstart)**

which help give applicants the necessary exposure to resources for helping with the application process. Legal Work Experience is also offered to members through affiliate partners of Aspiring Solicitors. The most unique feature of AS is the **Commercial Awareness Competition**. This is a competition described as a 'golden ticket' to securing a lucrative vacation scheme or training contract at a law firm. Here, you will develop your commercial awareness skills, get the chance to gain legal work experience and get a tailor-made suit if successful. **(Registrations are open!)**
