Barnsley College is a Government approved Multi-Academy Trust sponsor, responsible for setting up the Wellspring MAT. The sponsor appointed the original Members and has the right to appoint Directors. The sponsor is able to demonstrate robust governance and clear lines of accountability.

The Trust is responsible for the overall performance and finances of the Academies. The Trust agrees local Governance arrangements and Senior Leadership posts.

There is evidence of strong planning, the achievement of lasting educational improvement and financial expertise. The Trust has realistic plans for growth in the Yorkshire and Humber region and has current capacity to sponsor in PRU, AP, Special (BESD) and Primary sectors.

The Trust is the vehicle for sponsoring schools. There is no contractual relationship between the College and EFA in relation to the Trust. There is a firewall of liability between the two. The only formal interaction is the Sponsor appointments to the Trust Board and of Members
