4a (Code:) (Expenses \$ 608,822 including grants of \$) (Revenue \$) The PACC Caring Cupboard is a food pantry founded initially in 2001 by the children of the Palmyra Church of the Brethren. It became a ommunity food pantry operated by the Palmyra Church of the Brethren in the summer of 2004, and now is in its twelfth year of service. It is a nonprofit venture of the Palmyra- A Caring Community operating out of the former Royeris Flower Shop at 131 North Railroad St., Palmyra, PA. It is supported by donations of products and money from 28 churches, and innumerable businesses, organizations, and individuals. The Executive Director is the only full-time paid employee of PACC; therefore, it is an extensive volunteer organization involving over 125 people who are serving the clients, stocking shelves, receiving product donations, and packaging products. Our number of clients is growing with the current average of 140 per week. This translates into helping over 1600 people a month with food.

4b (Code:) (Expenses \$ 60,217 including grants of \$) (Revenue \$) The Phoenix Youth Center was developed as an outreach program where all youth are accepted and offered opportunities to build relationships, expand horizons and add valuable assets to their lives. The Youth Center serves approximately 450 youth from the community. year providing educational and recreational services to the youth of Palmyra. During the summer, the Youth Center was open for recreational use from 12-5, Tuesday and Thursday. In addition the Youth Center offered two months of free tutoring to Palmyra students grades 3-8. Tutors worked with the students to provide free tutoring so they could better prepare for the coming school year.

4c (Code:) (Expenses \$ 3,061 including grants of \$) (Revenue \$) PALMYRA AREA COUNSELING CENTER - The first clients were welcomed to the Palmyra Area Counseling Center on September 11, 1991. In short order, PACCis counseling center had established linkage with the local school systemis counselors and administrators which resulted in collaborative efforts on referrals, parenting skills training, peer mediation training, support groups for children of separated or divorced parents, etc. Nineteen years later, the Center is still a viable one in our community. Client services are provided by therapists and counselors employed by COBYS Family Services based in Leola, PA, a social services agency related to the Church of the Brethren. The Centeris fiscal structure includes an endowment fund which enables services to be rendered on a sliding fee scale based on household income.
