Exhibitor Expectations

If you are selling anything, you must have a business license on hand.

Must provide your own set-up including tents, tables and chairs.

Must be set-up by 10:00 AM and breakdown after 4:00 PM.

Vehicles can not be left in the unloading area - park before setting up.

Set tables and servicing area at least 3 feet back from the sidewalk.

All exhibits must remain true to the environmental theme.

Live animal and plant exhibits must be native to Florida.

Overnight parking is not allowed, set-up is Saturday morning.

Bring your own trash containers and bags. The public receptacles are for the visitors only.

Be responsible for the removal of your own trash. This is a litter free event.

Remember to collect and remit the 7% sales tax to the State of Florida.

Pets, balloons, and smoking are not allowed.

Valuables should not be left unattended. PIPS does not assume responsibility or liability for theft, damage or other loss of vendor's property and/or possessions.

Be prepared for windy/foul weather, bring extra tent straps and stakes.

Most of all have FUN and try to check out the other exhibits!
