- ☐ YES ☐ N/A Drawing or plan to indicate the work that you are doing, specifications, copies of receipts, or estimates for materials if you are doing the work yourself.
- ☐ YES ☐ N/A Spec sheets for materials being installed that fall under the Energy Code such as windows, doors, insulation materials, etc.

Owner Contractor Memorandum**

- You must ensure that the required inspections are scheduled and conducted.
- You must take full responsibility for the project and conditions.
- If it is found that someone other than yourself is doing the work, there will be a STOP WORK order issued
