Applicants are accepted on a "trial basis" and if the applicant / worker is not adaptable to the assignment and cannot be reassigned, or that information given has been misrepresented, the acceptance of this application can be terminated without other cause or notice. In addition, investigation will be made as to the applicants character, general reputation, personal characteristics, and adaptability to the particular position to be assigned. All applicants are required to undergo training / orientation provided by the state youth and CE director's office and under the supervision of the state youth and CE board. Applicants are not required to provide information which is prohibited by Federal, State, or local law.

REQUEST FOR CRIMINAL RECORD CHECK AND AUTHORIZATION: I hereby consent for the State Director's office to seek from local law enforcement any information which pertains to any record of conviction contained in its files or in any criminal file maintained on me whether local, state, or national. I hereby release the Police Department from any and all liability resulting from such disclosure.

APPLICANT'S STATEMENT: The information contained in this application is correct to the best of my knowledge. I authorize any references of churches listed in this application to give you any information (including opinions) that they may have regarding my character and fitness for youth camp work. In consideration of the receipt and evaluation of this application by the Church of God, I hereby release to any individual, church, youth organization, charity, employer, reference, or any other person or organization, including record custodians, both collectively and individually, from any and all liability for damages of whatever kind or nature which may at this time result to me, my heirs or family, on account of compliance or any attempts to comply with this authorization. I waive any right that I may have to inspect any information provided about me by any person or organization identified by me in this application.
