Purpose

Scene setting – previous discussion in February

Anne Lythgoe

- **Communities** Within a locality the accommodation available should reflect the life course transition those communities go through. But it should also reflect the specific needs of particular communities and be co-designed. Better definition needed of 'social infrastructure'.
- **Diversity** ageing, disability and social / community cohesion
- Community impact assessments
- Green spaces and environment new development should provide new green spaces. All neighbourhoods need to have planned green infrastructure.
- Linkages where does it link up to GM Moving, Local Industrial Strategy, for example?
- Threats to VCSE VCSE sector is going to be priced out of some places where we offer our services.
- Social value Social value should be a key thread in the Framework and not just procurement and contractual obligations

- Growth areas for social and community enterprise Could land be ring fenced to reflect VCSE activity. Could we create 'community business zones' or 'social enterprise zones'?
- Community anchors designated community anchor organisations and have them pinpointed on the map. Developer requirement to go talk to that designated organisation. This might also include communities of interest. Community anchors could put more powers in community hands.
- Community engagement the VCSE sector could support this
- Asset mapping VCSE also need to map out where we are and link with public sector asset mapping
- UTILISE designated community anchor organisations, DO community impact assessments, ENSURE good employment practice (including real living wage) and social value generated throughout (social, economic and environmental difference), DESIGN IN community cohesion, community and social infrastructure, ALLOW community asset transfer and local ownership, PROTECT AND ENHANCE green and blue infrastructure and let us help here VCSE could have a huge role in this where public budgets are being cut.... (don't just not have green space because there isn't a budget for the council to adopt it...)
