Pets that are picked up after 12:00 P.M. will be subject to an additional day's board. Doggie daycare can be scheduled for ½ or full day or at a discounted weekly rate.

Your pet will be fed and watered regularly per your instruction. Dogs will be walked and socialized. Pets will be housed in clean and enclosed quarters.

Animals need to be vaccinated at least two weeks prior to boarding or attending doggie daycare. Rabies is state law and should be given by a licensed Veterinarian. Proof of vaccinations is required at the time of entry for boarding. We can offer Bordetella, Distemper, and the flu vaccine for \$15.00 each for already established clients. Please be advised that Kennel cough vaccine only protects against a few strains of the Bordetella virus. Your dog may catch another strain of the virus while kept with numbers of other (even vaccinated) dogs. Much like sending a child to school and/or daycare, your dog may bring home a "cold" when boarded. Since all animals are at risk when boarded, The FSAC and SPCA will not be held responsible for upper respiratory infections and/or kennel cough virus.

All dogs/cats should be flea free. If animals are found with fleas a dose of Vectra will be applied and charged to your boarding bill. The charge for Vectra is \$10.00 per application.

Boarding Dogs will receive a bath prior to exit. Additional services such as a nail trim or ear cleaning can be added for \$10.00 each.

If you're animal becomes sick while in our care it will be taken to the nearest vet hospital for treatment. You will be responsible for any Vet cost associated with the care. We will make every effort to contact you prior to medical care.
