

**INFORMATION FOR A PETITION FOR REVIEW IN  
THE CALIFORNIA SUPREME COURT  
(Second District - - Criminal)**

After careful study of the opinion of the Court of Appeal in your case, your attorney has decided not to file a petition for review in the California Supreme Court. However, you have a right to file a petition on your own. In case you decide to do so, the following information and the attached sample petition should help you.

1. The Supreme Court will agree to hear your case only if there is an important question of law to settle or the Court of Appeal opinion is in conflict with other opinions. Other possible grounds for a review - - lack of jurisdiction of the Court of Appeal or lack of a majority of qualified judges - - almost never occur. (see California Rules of Court, Rule 8.500 (b).)

2. A petition for review must be received by the Supreme Court no later than forty (40) days after the filing date of the Court of Appeal opinion, a copy of which has already been sent to you. (see California Rules of Court, Rule 8.500 (e))

3. The sample petition for review attached must be modified to apply to your case.

4. You must mail copies of the petition to various interested parties. Note that there are different addresses depending on whether your case was in Division Six or where your trial was. You must list the addresses that you sent the petition to on the proof of service, which you sign and attach to the original petition filed with the Supreme Court. You can model your proof of service on the proof of service at the end of the end of the briefs filed by your attorney. Mail copies of the petition to:
