

Dear Regal Family,

We continue to stand with the people of Puerto Rico and St. Thomas and more specifically, those Regal team members who have family living in one of these two countries. With the help of American Airlines we were able to send packages to 17 families in PR last week. At this time, we are defining the details regarding a container shipment to both countries.

This would be our goal:

- Load and ship a container in the next 2 weeks to PR.
- Load and ship a container to St. Thomas by October 21st or earlier.
- The containers would primarily be used for Regal team members to ship items with labeled packages to their family members.
- The container would likely be dropped in a church parking lot or unloaded at the church. Details are yet to be determined.
- There would be no cost for Regal team members to ship the items. We would provide clear definition on how to package and label items, and the amount of materials that could be shipped later this week.

Save your receipts of your purchases for hurricane relief, for the possible reimbursement from Regal Cares.

We will share more information as it develops in the coming days and continue to pray for the mercy and comfort of God for all the families affected by the storm.

I have attached a flyer that provides a way to give financially. We have made a provision for you to donate vacation time/dollars if you desire to give that way. These flyers will also be available on the Regal Team member site. Please forward the flyer to people you think might want to donate to support Regal families.
