

PRIVACY POLICY

This Privacy Policy describes the types of information HYDROVIRGA collects and how we use and disclose that information. This Privacy Policy is incorporated into and subject to the terms of the HYDROVIRGA Terms of Use. By your submission of your information, you expressly consent to our collection, use and disclosure of your information in the manner described in this Privacy Policy. If you do not agree to the terms of this Privacy Policy, please do not use HYDROVIRGA. HYDROVIRGA reserves the right to modify this Privacy Policy at any time and without prior notice. The date of the most recent revision will appear on this page, and your continued use of HYDROVIRGA will constitute your acceptance of any revisions of this Privacy Policy.

If you choose to use HYDROVIRGA, we may require you to provide personal information as indicated on the HYDROVIRGA site, whether as part of the registration process or in connection with your use of the HYDROVIRGA site.

We collect and store the following information:

- Email address, IP address, and physical contact information; and
- Other information automatically collected whenever you interact with HYDROVIRGA, such as computer sign-on data, statistics on page views and traffic to and from the HYDROVIRGA site. For example, we use "cookies" (small data files that are placed on your computer) so that we can recognize your browser and record such interaction information. You can disable the use of cookies through your browser settings, however this is likely to affect your ability to use certain features of the HYDROVIRGA site.

We do not knowingly collect personal information from children under the age of 13. If you are under the age of 13, please do not use the HYDROVIRGA site or services.

We may use your information as follows:

- to provide information regarding HYDROVIRGA;
- to verify your identity when you sign in;
- to encourage safe online experiences and enforce our policies;
- to customize users' experience, analyze site usage, improve and measure interest in our services, and inform users about services and updates;
- to communicate administrative announcements when we need to provide users with information that may affect their use of HYDROVIRGA; and
- to deliver to you information that is targeted to your interests. Upon receipt of the first communication of this type, you will have the opportunity to opt-out of future communications by following unsubscribe instructions described within the communication. As part of your registration on HYDROVIRGA, you agree that you may receive certain administrative communications from HYDROVIRGA, and you will not be able to opt out of receiving such administrative communications.

We do not sell or rent your personal information to third parties for their marketing purposes without your explicit consent. However, we may disclose your personal information as follows:

- to third parties to enforce our Terms of Use and other HYDROVIRGA agreements and policies, or to protect anyone's rights, property, or safety;
- to third parties to respond to claims that photos or other content that you upload violates other's rights;
- to an acquirer of all or substantially all of the equity, assets or business of HYDROVIRGA;
- to service providers who help with our business operations and assist in the delivery of HYDROVIRGA services under obligations of confidentiality;
- to law enforcement or other government officials in order to investigate, prevent, or take action regarding illegal activities; and
- as otherwise required by law.

If you provide your information to us on the Website (including, without limitation, through a "Contact Us"

submission or a response to a product listing), we may use that information to contact you.

To prevent unauthorized access, promote data security, and encourage appropriate use of information, we use a variety of tools to assist in the protection of your personal information. However, "perfect security" does not exist on the Internet, so we make no guarantees.

You agree that we may transfer your personal information to other countries as required in connection with any of the purposes set forth in this Privacy Policy.

Except as set forth above, we do not disclose your personal information to the operators of such third-party websites without obtaining your consent. We are not responsible for the privacy practices of such third-party sites. If you choose to visit one of these third-party sites, you should review the privacy policy posted on such third-party site to understand how that party collects, uses and discloses your personal information. Under California Civil Code Section 1798.83, if you are a California resident and your business relationship with us is primarily for personal, family or household purposes, you may request certain data regarding our disclosure, if any, of personal information to third parties for the third parties' direct marketing purposes.
