### Risk of Assessment Summary

In this Risk Assessment Summary, the term “**the Adventure Activity**” means all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by **Surf Sister Surf School Ltd.** including but not limited to: walking, surfing, boogie boarding, swimming, hiring surfboards, wetsuits and boogie boards, Orientation and instructional courses, seminars and sessions and any other activities, events and services in any way connected with or related the Activities.

Accidents while engaging in the Adventure Activity occasionally happen. The Adventure Activity includes inherent and foreseeable risks of harm, personal injury or even death. While the variety of risks is more than can be listed here, **Surf Sister Surf School Ltd** takes this opportunity to identify the more obvious and frequent risks.

#### **Activity Risks**

The Adventure Activity presents a number of inherent and significant risks, dangers and hazards that may result in personal injury or death of participants, property damage, loss, expense or inconvenience. These include:

- loss of balance, falls, slips and trips while travelling by foot to and from the Adventure Activity;
- being hit by the board, other surfers and their boards which could result in cuts, bruises, abrasions and concussions
- hitting the bottom of the ocean
- sprains, strains, broken bones, paralysis, even death
- exhaustion, hypothermia, dehydration, sun burn
- exposure to poisonous and/or carnivorous sea creatures
- drowning
- changing and inclement weather conditions including storms, high winds, high waves, and lightning
- failure of equipment including the boats, wetsuits, helmets and personal flotation devices;
- the possibility that your child may not heed safety instructions or directions given to the group or delivered individually;
- negligence on the part of other participants; and
- **NEGLIGENCE ON THE PART OF SURF SISTER SURF SCHOOL LTD AND ITS AGENTS, PRINCIPALS AND EMPLOYEES, INCLUDING THE FAILURE ON THE PART OF SURF SISTER SURF SCHOOL LTD. AND ITS AGENTS, PRINCIPALS AND EMPLOYEES, TO SAFEGUARD OR PROTECT PARTICIPANTS FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN THE ACTIVITIES.**

Communication in the remote terrain which is sometimes used for the Adventure Activity is difficult and in the event of an accident, rescue and medical treatment may not be readily available.
