Biographical / Historical Note

This Record Group contains the homogulation of the succession of Joseph Amoros, native of Mataro, Catalogne. He died on August 2, 1822, without descendants. This succession contains the appointment of a curator of his estate, an inventory of the estate, a list of articles from the estate sold at auction, coverage of legal and funeral fees, assessment of various properties purchased by Juan Puich as curator of the estate and the approval to stop mortgage payments.

Receipted bill for \$51.00, cost of copies of inventories, petitions, lifting of seals, etc. Bill is approved for payment by A. Morphy, signed by Christov de Armas, Notary Public. 2 pp.

Memorandum listing acts whereby a lot situated in Faubourg Marigny, forming the corner of Marigny and Moreau Streets, with frontage of 60 ft in Marigny by depth of 120 ft, is transferred. 2pp.

Memo Acts in connection with this estate [succession of Juan Puiche]. 4 pp.

October 1, 1829

Authorization given by the Court of the Probate to Juan Puich [sic] to receive and hold goods and effects of Francisco Ramirez, make inventory, etc. 6 pp.

January 5, 1830

Certified copy of Order of Court of Probate, for homogulation of account rendered by Juan Puich, testamentary executor of estate of Francisco Ramirez, also authorizing him to turn over to the Widow Ramirez, money or property. 2pp.

March 16, 1830

Order for cancellation of Bond furnished by Puich and Ramirez jointly, Puich to retain funds which belong to the heirs, amounting to \$1200.00. 2pp.

November 12, 1834

Certified Copy of Judgment rendered by Court of Probates in the matter of mortgage existing on property acquired by Barhelemy Montreuil from widow Gravel.

The judgment orders that Montreuil suspend payment of the lots until such time as the mortgage is cancelled, after which are to comply with conditions of the adjudication. 2pp.

Ca. December, 1834 [labeled as November 28 by WPA] Part of Process Verbal of meeting of friends and family of Jean Xavier Gravel, held by order of November 28, 1834, on petition of Mme Gravel.

At this meeting, the members decided that there was enough property to take care for the heirs' rights, ant that Mme. Gravel, in order to render an accounting to her daughter Mme. Thielen, should sell (1) a lot on Marigny Street between Casacalvo and Moreau, (2) one lot forming corner of Mandeville and Moreau, (3) one lot in in the new Faubourg Marigny.

Note begins with "Dame Gravel, in preparation of a proposed plan to live in France". It shows that Mme. Gravel, as tutor to her minor children, mortgaged her property as security. She petitioned the court for cancellation of this mortgage. Petition was granted.

No Date

Memorandum of facts which lead to judgment. By the terms of the will of Jean Puich before Caire, October 29, 1832, Manuel Francis Tio was made universal legatee. Puich had acquired the three lots in Faubourg Marigny from Dame Gravel. These lots were mortgaged in favor of her minor children at the time of the sale to Puich. Puich, in turn, sold them to Montreuil, and it is the widow Montreuil and Eugene Macarty who petitioned for a clear title.

This memorandum traces the ownership of property back to 1809 when it was acquired by Lambert Detry from Bernard Marigny by Act before Godfry, July 20th.
