## **Biographical / Historical Note**<sup>1</sup>

This collection documents part of the life of J. Ward Gurley, Jr., Orleans Parish District Attorney. Gurley was born in New Orleans in 1851 and graduated from Washington and Lee University before he was admitted to the bar in 1873. Two years later, he was appointed Register in Bankruptcy for the District of Louisiana. From 1880 to 1883, he served as Orleans Parish Assistant District Attorney, and in 1896 he became U.S. District Attorney for the Eastern District of Louisiana while continuing a private practice in partnership with Delos C. Mellen. In 1900, Gurley was elected Orleans Parish District Attorney and dissolved his partnership with Mellen.

Gurley married Aurora Huntington in 1878; she died in 1892. They had two daughters, Helen and Aurora. The collection houses several letters written between Gurley and his daughter, Aurora, while she was a student at The Castle School, also known as Miss Mason's School for Girls, in Tarrytown, New York. The school was originally built for John J. Herrick in 1854; Miss Cassity Mason purchased it in 1895 and operated it as a school for girls until her death in 1933. Students from the United States and foreign countries attended the institution, which Mason advertised as a post finishing school for young women. Aurora Gurley married Edward McGehee in 1902; their wedding invitation is included in this collection.

Gurley was known as one of the fathers of Audubon Park. He served as the first president of the Audubon Park Commission from 1886 to 1903. It was his dream to have Frederick Law Olmstead draw up a plan for a million-dollar improvement to the park. The collection houses several items documenting the very early years of the park, including a copy of the original charter.

On July 20, 1903, Gurley was assassinated by Lewis W. Lyons, a disgruntled client. Lyons had been accused of stealing a diamond stickpin in 1895; once he was cleared of the charges, he sued his accusers for \$5,040. Gurley's law partner represented Lyons in the 1895 suit. When the court failed to award Lyons the damages, he hired Gurley to appeal the case to the Louisiana Supreme Court, which upheld the lower court's decision. Lyons, incensed by the court's refusal to reverse,

turned his ire toward Gurley by threatening him, and, in 1901, Lyons challenged Gurley to a duel, which Gurley ignored. Lyons shot Gurley at Gurley's law office in the Mecheca Building on Common Street before turning the gun on himself. Lyons survived his self-inflicted wound. Other than memorials written by his friends after Gurley's death, and a few newspaper clippings, there are no items in the collection concerning Lyons or Gurley's assassination.

			Gurley expressed hope that Dr. Custis was "doing the right thing" by removing Aurora's growth. "I greatly fear most doctors are too fond of cutting." Aurora wished to go to the Cornell [boat] races in Ithaca, New York, and Gurley expressed concern about the protection of Aurora's virtue while she was at the races and during her return train trip to New Orleans at the end of the school year.
			Gurley believed "young ladies" should be "properly protected for the purpose of commanding from the world the proper respect and good opinion due a lady." He believed men would judge Aurora "according to the measure of protection" by which she was "surrounded" and that they might "rank [her] accordingly." He observed that she knew "all the dangers to which" Aurora "may be subjected" and the importance of not deviating "from the most dignified, cautious, and proper conduct."
	2004.028.31.11a- 2004.028.31.11b	1902 May 18	Gurley expressed grave concern for his daughter during her train trip home. "It is very unfortunate for a young girl to have to travel alone. Men, and those who look like gentlemen, are so apt to attempt to annoy [young girls] if they do not actually insult them, and there are always men around who are constantly watching for any and every opportunity to take whatever advantage of a girl they can when they see her unprotected. It is perfectly detestable Many young ladies have had very unpleasant experiences even in sleeping cars and sometimes even with the conductors. When traveling, be dignified and quiet always. Do not become sociable to or with any stranger don't do anything to attract attention." Gurley admonished Aurora to avoid any medical procedures until she returned to New Orleans.
