The Bernard Sage Papers are a collection of personal correspondence from Sage's relatives, the Lewis family of Opelousas & Atchafalaya region, Louisiana, dating from 9 August 1851 to 13 February 1917. These letters deal with family news, river plantation operations, land sales, the effects of Reconstruction in these areas, Australia Plantation, camp meetings & religious revivals. Also included in the collection are Bernard Sage's notes on Constitutional principles and governmental theories, concerning states' rights and secession.
