Scope and Content Note

This collection houses documents concerning claims to the US Congress for the recovery of money lost from the confiscation of cotton during the Civil War.

In 1863 Samuel Templeton, a Union sympathizer, had a cotton plantation located 15 miles west of Miss river from Goodrich's landing in Carroll parish. In that year, Templeton claimed to have harvested 1000 bales of cotton which were ready for market.

That same year, Grant's labor force came to Lake Providence area to proceed down Baxter Bayou and Bayou Macon to avoid Confederate guns at Vicksburg. The laborers were going to Vicksburg to cut a canal to divert the Mississippi River away from the bluff at Vicksburg (which would have created an oxbow lake at Vicksburg), so they could bring union forces safely down the river and avoid guns at Vicksburg.

When confederate sympathizers, most especially Quantille's Raiders, the first gang which Jesse James joined as a young boy of 15, learned of this plan, the levees above Lake Providence were cut in order to flood Baxter Bayou and Bayou Macon in order to prevent the Union forces from using this route.

Residents of the area, including Templeton, were ordered to burn their cotton before the troops arrived. Templeton did not wish to burn his cotton, but knew his refusal would not matter because the cutting of the levees would flood his plantation and ruin the cotton bales. In order to prevent the burning and flooding the cotton harvest, Templeton had the cotton moved to higher ground west of Bayou Macon and he and his family moved to Morehouse Parish.

In the fall of 1863 union troops took 30 bales of Templeton's stored cotton. U.S. treasury records indicate that the government eventually sold the 30 bales of cotton in Cincinnati for \$9,200. The documents housed in this collection record the Templeton family's attempts to be reimbursed for the confiscated bales. Included in the collection are a Civil War pass, loyalty oath, and certificate qualifying Templeton to vote.

Of additional significance in the collection are documents relating to William G. Wyly (1831-1903), who became a justice of the Supreme Court of Louisiana. Wyly and his brother, James G. Wyly, Templeton's brothers-in-law, also filed claims for reimbursement for confiscated cotton. After Templeton's death, the two men assisted their niece, Emma Templeton Wood, in her attempt to recover damages from the government. The collection includes letters of introduction, including one from Henry Clay Warmoth, given to W.G. Wyly, Wyly's deposition, and a pamphlet outlining the Wyly brothers' claim against the government.
