### **Biographical / Historical Note**

Dr. Ellis Ralph Lupin (1931-2014). A native and lifelong resident of New Orleans, Lupin was a prominent physician, attorney, and philanthropist.

He obtained a B.S. in Pharmacy from Loyola in 1952, then a Medical Doctorate Degree from Louisiana State University in 1956, after which he served as a resident in Obstetrics and Gynecology at Touro Infirmary until 1958. In 1988 he obtained a law degree from Loyola Law School.

Lupin began his work as an obstetrician-gynecologist in 1958 when he served as the chief of the OB-GYN Department at the 48<sup>th</sup> United States Air Force Hospital in Laken Heath, England. When his tour of duty ended, he returned to New Orleans and became a partner/co-founder and group organizer of the Women's Medical Center in Gretna. He held a leadership position in the practice until 2010, when he founded the Lupin Women's Health practice. Lupin held senior positions on the staffs of Meadowcrest and West Jefferson hospitals. He was one of the leaders in the Westbank Physicians Network (WPN) and remained an officer until the agency ceased to exist. He was an original board member of the state commission on home health care and joined the first Private Home Health Agency in Louisiana.

Lupin and his brothers, Dr. Arnold Lupin and Dr. Sam Lupin, founded and operated St. Charles General Hospital in New Orleans and successfully operated the facility until its sale to Tenet Healthcare Corp. in 1985. Their successes led the brothers to form the Lupin Foundation, a non-profit foundation that has helped many other non-profits.

Lupin served as chair of the Vieux Carré Commission. He served on the Louisiana State Museum Board for nearly four decades and twice served as chair. He also served on the boards of the Louisiana Museum Foundation, the New Orleans Museum of Art, the Lupin Foundation, the New Orleans Center for Creative Arts (NOCCA), the New Orleans Symphony, Children's Hospital of New Orleans, Jewish Family & Children's Services, the local chapter of the American Red Cross, the University of New Orleans Foundation, the Audubon Institute, the National World War II Museum, the Upper Pontalba Commission (which he chaired), the Sophie Gumbel Guild, the New Orleans Opera Association, the New

Orleans Ballet Association, the Jewish Foundation, Young Audiences, Bridge House and many more organizations.

He ran for the City Council, District C, in 1990. Although not successful in that race. He served in the Air Force (1956-1963) and in the Louisiana National Guard (1933-1997). He served as a consultant to the U.S. Surgeon General for Medical and Legal Affairs.

### **Scope and Content**

Collection includes various papers from throughout Lupin's professional career and philanthropic pursuits. There are items related to his educational pursuits, Loyola College of Pharmacy and Loyola Law School, as well as some papers related to his children's education. There are assorted documents, correspondence and reports related to a variety of professional and philanthropic organizations that Lupin worked with or help to found. Also included is correspondence, holiday cards, and misc. papers from his personal life. There are also items related to his unsuccessful run for City Council, District C, in 1990. Papers and invoices from local businesses and banks are included as a representation of the local community, particularly for companies that are no longer in operations (DH Holmes, K&B, Godchaux, Maison Blanche, etc.).

Collection also includes papers and items related to the Lupin's family life, such as calendars, family research, and correspondence.
