Biographical/Historical Note

Pierre Cenas [c. 1749-c. 1824], with his son, Blaise [1776-1814], migrated to New Orleans in the late 18th century. After 1804, Pierre, and his second wife (Marie Josephe Renne) returned to Marseilles, France, where family members resided at least until Marie Josephe's death in 1854. Several letters and documents concern the settlement of Pierre's estate on behalf of his American grandchildren.

Blaise, born in Lyon, was sent to Philadelphia to learn "American business," where he met Pauline Catherine Baker [1873-1854] [hereinafter CBC], daughter of Hilary Baker, mayor of Philadelphia. They were married in 1802 and had four children: Hilary Breton [1805-1859] [hereinafter referred to as HBC], Augustus Henry 1 [b.1807] [hereinafter referred to as ARC] who became a physician, Peter [1810-1845], and Marie Magdelena [c.1807-1815].

Blaise returned to New Orleans ca. 1803 to work, where he served as New Orleans' first postmaster, 1804-1810. In this capacity Blaise Cenas established the first workable postal system and post roads in the New Orleans area. After Blaise's death, his widow married William H. Christy [1791-1865] and gave birth to three more children: George William, William Hull, and Mary Ann.

Scope and Content

The collection consists of letters, papers, memorabilia of Hilary B. Cenas family. Documents nineteenth century education, travel, travel routes (especially over water), economy, politics, slavery, construction costs and supplies, medicine, mourning customs, hurricanes, yellow fever, cholera, Jenny Lind, Oakley plantation, railroads, Lafayette's visit to the United States 1824-1825, antebellum banking problems in New Orleans, 1844 presidential election, dueling, gambling, St. Charles Hotel, Norbert Rillieux, receipt issued by Freedman's Board, WWII membership card, Civil War Letters, Sam Houston, receipts (1916-1918) from various New Orleans merchants including pharmacies, opticians, dry goods merchants, jewelers, booksellers and stationers, Solari's. Contains genealogical data on Cenas Baker, Pierce (Peirce), Williams families.
