Biographical/ Historical Note

Junis Beebe was President of the New Orleans General Council in 1848 and was in the race for mayor in 1850 before poor health forced him to drop out. His brother Decius, who apparently moved to Massachusetts some time in the late 1840s or early 1850s, was a merchant and proprietor of Beebe and Company in New Orleans. All of the Correspondence is addressed to Decius Beebe in Massachusetts from family members and business associates in this city. In addition to family and business matters, these letters often contain information about events taking place in New Orleans.

Many letters are devoted almost exclusively to the Yellow Fever epidemics that were then common in the city. Others are variously concerned with the Vigilance Committee uprising in 1858, economic conditions in New Orleans and the problems of communicating from South to North during the Civil War.

Scope and Content

The collection consists of newspapers, business documents, bills, receipts and letters relating to the Beebe family of New Orleans during the period between 1840 and 1868.
