Biographical / Historical Note

Scope and Content

Miscellaneous historical records collected by George L. Smith. There is colonial marriage record dated 1757. There are letters sent to William Beer (1849-1927), a library at Howard Memorial Library. Other miscellaneous correspondence includes a letter sent by W.C.C. Claiborne to Samuel Smith, and a published letter from Charles Etienne Arthur Gayarre (1805-1895) to his acknowledged, natural, son, Charles Nicholas Arthur Gayerre (b.1825), a free person of color, challenging his attempt to pass for white. There is a certificate of membership to the Louisiana Histrionic Association, and a letter from the Mercantile Library Association. There are assorted documents related to the Schweitzer family (naturalization paper, voter registration, passport), and papers related to political appointment of John A. Watkins. Other assorted items of varying topics are also included in the collection.

There are also documents related to state expenditures for criminal prosecutions. These include various warrants, travel expenses, room rents for judges chambers, etc. These items are from the fall term of 1830.
