



Owner Agreement

I _____ hereby certify that my **dog(s)** _____
is/are in good health and have not been ill with any communicable diseases or parasites in the last 60 days and have not harmed or shown aggression or threatening behavior towards any person or animal.

I agree to the following:

When I use Wag'n World for daycare, boarding and grooming, I understand that my dog is participating in an open play environment and inherent risks can occur even while supervised.

Risks such as:

- **Transfer of communicable illnesses such as but not limited to Bordetella virus also known as kennel cough and parasites. (Initial) _____**
- **Injuries, most minor, such as abrasions, cuts, broken nails, soreness, injuries to pads, and razor burn due to matted pates (grooming). (Initial) _____**

I understand Wag'n World has evaluated the temperaments of all dog(s) engaged in group play and will use reasonable care to avoid all injuries at best. In the event an injury does occur at Wag'n World, **I agree to hold Wag'n World harmless from damages resulting from such injury (i.e. dog fights & group altercations).** I understand if any health or injury occurs while Wag'n World is caring for my dog(s), that the staff will care for my pet as they deem best for my pet. **I agree to pay all veterinary charges required and assume all financial responsibility for treatment of my pet.** If your dog requires medical attention while in the care of Wag'n World, **you agree to be solely responsible for the payment of all medical bills** for your dog(s) and release Wag'n World, it's officers and employees from any and all responsibility for, or claims, damages, resulting from such medical care. (Initial) _____

I understand that if I drop off a dog that immediately presents with possibly contagious symptoms such as loose stool, runny nose or a cough, I will be required to arrange for immediate pick up. If I am unavailable, **Wag'n World will bring my dog to an available vet for treatment and boarding at my cost.** (Initial) _____

In the event your dog(s) need to be taken to the veterinarian (we typically use our local 24 hour vet/standby Sunset Emergency Clinic). There is a \$20 traveling fee associated per dog. (Initial) _____

I am solely responsible for any damage or injury my dog(s) cause to a person, property and animal while at Wag'n World. (Initial) _____

Wag'n World and staff are not liable for any health or behavioral problems that develop while at Wag'n World. (Initial) _____

I understand the hours of operation: Monday-Friday 6:30am-7pm, Saturday 9am-5pm, Sunday 2pm-6pm. **Late fees will apply if my pet is picked up after closing hours. \$1.00 per minute will be billed for the first 15 minutes.** 15 minutes after we close and no communication has been made to Wag'n World staff for dog pick up within 1 hour prior to closing, each dog will be boarded and charged a \$35 boarding fee at the owners expense with a \$2.00 meal charge.
