PAYMENT TERMS

Deposit payment (40% of total) will be accepted for bookings received more than 20 weeks (**18 November 2016**) prior to event with the remaining payment (60% of total) due 12 weeks (**13 January 2017**) prior to event. Full payment (100% of total) is required for bookings made within less than 20 weeks (**18 November 2016**) prior to event.

The 'Early Bird Offer' only applies to a limited number of tickets and will be available on a first come basis until stocks last, therefore early bird rates will only be applicable to bookings made before selling out (or **30 November 2016** exclusively dependent on availability)

Payments are due 7 days from date of invoice. For bookings received less than 8 weeks (**10 February 2017**) prior to event must be paid immediately. Ironmonger Events reserves the right to cancel bookings, with the loss of deposit or cancellation fees charged, as detailed below, where the payment terms are not met. All invoices unpaid after their respective due date for payment shall carry interest on the amounts outstanding from time to time at a rate of 2% above the current base rate of HSBC.

CANCELLATIONS

The client may only terminate a booking by notice in writing to Ironmonger Events Limited. Ironmonger Events shall be entitled to charge:

- The total value of the package ordered, verbally or in writing, if the cancellation is received less than 12 working weeks (**13 January 2017**) prior to the commencement of the event.
- 50% of the total value of the package ordered, if the cancellation is received within more than 12 weeks (**13 January 2017**) prior to event but less than 20 weeks (**18 November 2016**) before.
- The loss of the deposit or a 10% cancellation fee, whichever is the greater amount for any cancellation to a confirmed booking received more than 20 weeks prior to the event.

CONFIRMATION OF BOOKING

A receipted invoice will be issued as booking confirmation and the balance invoice, where appropriate, will be sent in good time for payment to be affected by the final due date. All tickets and/or admission passes will be ready before and no later than 4 weeks in advance of the event and available to redeem on receipt of receiving final payment only.

Office collection is recommended for the aforementioned accreditation items prior to event day. Should you wish to receive via registered post to a Hong Kong address (please note: standard or overseas postage is not an option), Ironmonger Events do not accept responsibility for delivery or additional costs incurred.
