RESOLUTION # _____-2017

A RESOLUTION OF THE THREE FORKS CITY COUNCIL ADOPTING & LEVYING THE ASSESSMENTS FOR THE 2017-2018 STREET MAINTENANCE DISTRICT NO. 1

WHEREAS, pursuant to §7-12-4425, MCA the City Council held public hearings on July 25th and August 8th, 2017, to establish the preliminary budget for Fiscal Year 2017-2018; and

WHEREAS, pursuant to §7-12-4425, MCA the Council should levy and assess the amount for each district by the second Monday in August annually. However, it was always believed that the assessment would need to be finalized by this date which is before the annual budget is finalized, therefore the City has not met this requirement. The City recently learned that §7-12-4425, MCA states “estimated” so in future years the City will estimate the assessment via resolution no later than the second Monday in August annually; and

WHEREAS, pursuant to §7-12-4426, MCA, the City Council may levy and assess on all of the lots, parcels and tracts within Street Maintenance District No. 1. The total assessed for Fiscal Year 2017-2018 is \$45,000.00; and

WHEREAS, pursuant to §7-1-4127, MCA the City Clerk published in the Belgrade News a notice of the existence of this Resolution and the list of assessments to be available for inspection at the City Office (206 Main Street) of Three Forks, Montana on August 17, 2016, and in the Bozeman Daily Chronicle on August 20, 2017; and

WHEREAS, the City Council held a public hearing on August 22, 2017 to hear objections to the final adoption in the City Council Chambers, 206 Main Street, Three Forks, Montana; and

WHEREAS, _____ objections were presented to the Council.

NOW THEREFORE BE IT RESOLVED pursuant to §7-12-4425, MCA the Three Forks City Council hereby levies and assesses by the second Monday in August, the annual street maintenance upon each lot, parcel and tract within Street Maintenance District No. 1 with the total cost of \$45,000.00 which applies to the assessable area of the entire district, exclusive of streets, avenues, alleys and public places.

Attached hereto and marked Exhibit “A” which is hereby incorporated herein by reference is a list which describes (1) each lot, parcel and tract of land within Street Maintenance District No. 1; (2) the total number of square feet; and (3) the amount levied against each lot, parcel and tract.
